Hi Jennifer,

We do not agree that the new activity only needs to be assessed against BAT 4 of waste Treatment BAT conclusions. You will need to consider all of the relevant BATs in the Waste Treatment conclusions that is applicable to your new activity. We need this to progress your application to the next determination stage. BAT assessment is required for all new processes and installation operations.

The operator techniques and the additional document you provided in response to the Not Duly Made request are not comprehensive and do not cover full BAT assessment.

We appreciate that some of the BATs may not be applicable but we still need to consider and state that, that is the case. There are range of BATs that are applicable to the proposed activity that you have not considered. For example BAT 5 considers handling and transfer procedures with the aim to ensure that wastes are safely handled and transferred to the respective storage or treatment. Again, BAT 14 covers diffuse emissions to air which may result from the shredding operations of the hazardous WEEE activity.

Note that your existing permit is not yet reviewed against the provisions of the Waste Treatment BAT Conclusions. Some of the limits in your current permit is out of date with the BAT requirements. For example Table S3.1 of your permit has point source emissions limits of 20mg/m3 for total suspended particulates against 5mg/m3 that is now required under BAT 25.

We have noted that you want to keep the Reg 61 response separate. However, we need an equivalent document that covers full BAT assessment to progress this application. If you chose not to provide it at this stage, we will formally request it using Schedule 5 Notice at a later date but we want you to be aware that this will cause a delay to the overall determination timescale.

In addition:

We need you to provide a copy of the updated risk assessment that you mentioned in your Non-technical Summary. You stated in the NTS that 'A copy of the risk assessment has been included with the application'. We cannot find this in our records.

We need you to provide the BAT assessment and risk assessment documents to us on or before 22/02/2023.
