

# APPOINTEES TO THE CMA'S VETERINARY ADVISORY PANEL

### **Abi Harland**

Abi qualified as a veterinary nurse in 2017, while working at an independent practice. She currently works at a Medivet first opinion practice in Dorset. She has worked in referral hospitals and first opinion practices for Linnaeus, VetPartners and Vets4Pets. She has a keen interest in Schedule 3 procedures and wound management.

### Helen Rippin

Helen qualified as a veterinary nurse in 2007. She currently works for an independent practice in South Wales, where she is a part owner. She is also a student nurse Clinical Coach and has a particular interest in surgery and anaesthesia.
