NATIONAL HEALTH SERVICE, ENGLAND

The General Medical Services Statement of Financial Entitlements (Amendment) (No. 2) Directions 2024

The Secretary of State gives the following Directions in exercise of the powers conferred by sections 87, 272(7) and (8) and 273(1) of the National Health Service Act 2006(a).

In accordance with section 87(4) of that Act, the Secretary of State has consulted with the body appearing to the Secretary of State to be representative of persons to whose remuneration these Directions relate.

Citation, commencement, extent, application and interpretation

- 1.—(1) These Directions may be cited as the General Medical Services Statement of Financial Entitlements (Amendment) Directions 2024.
- (2) These Directions come into force on 1st October 2024 except as otherwise provided for in paragraph (3).
 - (3) Directions 2(2)(b) comes into force on 1st January 2025.
 - (4) These Directions are given to NHS England.
 - (6) These Directions extend to England and Wales and apply to England only.
- (7) In these Directions, "the Principal Directions" means the General Medical Services Statement of Financial Entitlements Directions 2024(**b**).

Amendment of the Principal Directions

- 2.—(1) The Principal Directions are amended as follows.
- (2) In Part 4 (payments for specific purposes), in section 16 (dispensing)—
 - (a) in paragraph (3)—
 - (i) for sub-paragraph (a) substitute—
 - "(a) For—
 - (i) products listed in Part VIIIC(ii) of the Drug Tariff, the basic price of the drug or appliance, which is the price calculated in accordance with Part II clause 8 (Basic Price), clause 10 (A and B) (Quality to be supplied), clause 11 (Broken Bulk), clause 13 (Reconstitution of Certain Oral Liquids) and Part VIIIC(ii) of the Drug Tariff,

- (ii) other products, the basic price of the drug or appliance, which is the price as calculated in accordance with Part II clause 8 (Basic Price), clause 10 (A and B) (Quantity to be Supplied), clause 11 (Broken Bulk), clause 13 (Reconstitution of Certain Oral Liquids) and Part VIIIA (Basic Prices of Drugs) of the Drug Tariff, less a discount calculated in accordance with Part 1 of Annex G.".
- (ii) in sub-paragraph (c), for "the discount has been calculated in accordance with Part 1 of Annex G", substitute "any discount in accordance with sub-paragraph (a)".
- (b) in paragraph (4)—
 - (i) after sub-paragraph (e), insert "(f) sub-dermal contraceptive implants".
- (3) In Annex G (dispensing payments)—
 - (a) in Part 2 (dispensing feescale for contractors that are authorised or required to provide dispensing services), for the first table substitute—
