NATIONAL HEALTH SERVICE, ENGLAND

The General Medical Services Statement of Financial Entitlements (Amendment) Directions 2024

The Secretary of State gives the following Directions in exercise of the powers conferred by sections 87, 272(7) and (8) and 273(1) of the National Health Service Act 2006(a).

In accordance with section 87(4) of that Act, the Secretary of State has consulted with the body appearing to the Secretary of State to be representative of persons to whose remuneration these Directions relate.

Citation, commencement, extent, application and interpretation

- 1.—(1) These Directions may be cited as the General Medical Services Statement of Financial Entitlements (Amendment) Directions 2024.
- (2) These Directions come into force on 1st September 2024 and except as otherwise provided for in paragraph (3), have effect from that day.
 - (3) Direction 2(2) and 2(3) have effect from 1st April 2024.
 - (4) These Directions are given to NHS England.
 - (5) These Directions extend to England and Wales and apply to England only.
- (6) In these Directions, "the Principal Directions" means the General Medical Services Statement of Financial Entitlements Directions 2024(b).
