Thank you. Please could you make the inspector aware that despite being a B road the B6045 is a designated lorry route and is used as such by vehicles going to/from the A1- so he should not assume that these lorries will only be using A roads to the site. Local residents have tried in the past to try and get the B6045 closed to HGV's but have been unsuccessful.

In response to a residents petition the relevant Notts County Council Committee report dated 20<sup>th</sup> Jan 2020 states:

"The B6045 acts as a key east-west route across Bassetlaw, providing a link between Gainsborough and Worksop, and as such it is expected that it will carry HGV traffic. More locally, the road provides access to the A1 for businesses located in the Ranskill and Sutton cum Lound areas".

To reach the B6045 HGV traffic can end up passing through the centre of Blyth (including past the local school).
