SoS has reviewed the submission 'Senior Civil Servant (SCS) Resourcing, and Handling of Future SCS Recruitment Exceptions'.

SoS is content for the temporary appointments outlined in the submission to be made – with the exception of the 'Head of Delivery Unit', where he did not agree with the 9 month time period proposed, given his desire for the permanent recruitment to be done at pace (see below). This should instead be a 3 month temporary appointment.

For all of these appointments, SoS would like reassurance that the process for permanent appointments will follow rapidly to give the long-term stability needed. SoS recognises there will be a need for exceptions, but he stresses that the norm should be for permanent recruitment solutions to be prioritised and processed 'within weeks rather than months'. He would like regular updates on the progress of these recruitment campaigns, and for them to attract talented candidates from external to Government.
