EXPLANATORY MEMORANDUM FOR EUROPEAN UNION LEGISLATION WITHIN THE SCOPE OF THE UK/EU WITHDRAWAL AGREEMENT AND WINDSOR FRAMEWORK

COMMISSION DELEGATED DIRECTIVE (EU) 2024 / 1416 OF 13.03.2024 AMENDING DIRECTIVE 2011/65/EU OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL AS REGARDS AN EXEMPTION FOR CADMIUM IN DOWNSHIFTING QUANTUM DOTS DIRECTLY DEPOSITED ON LED SEMICONDUCTOR CHIPS

Submitted by the Department for Environment, Food and Rural Affairs 14th October 2024

SUBJECT MATTER

- 1. EU Directive 2011/65/EU on the restriction of the use of certain hazardous substances in electrical and electronic equipment (the RoHS Directive) sets limits on the use of ten hazardous substances in electrical equipment, including cadmium and lead. There is a list of exemptions, which is updated on a regular basis, where for scientific or technical reasons alternatives do not exist and their continued use in particular applications is considered justified.
- 2. This regulation extends the duration and increases the scope of exemption 39a in Annex III to the RoHS Directive. Exemption 39a covers the use of cadmium selenide in downshifting cadmium-based semiconductor nanocrystal quantum dots for use in display lighting applications.
- 3. Specifically, following public consultation and technical studies, it was concluded that the duration of the existing exemption should be extended, and the scope of the exemption should be expanded to cover cadmium in downshifting semiconductor nanocrystal quantum dots directly deposited on LED semiconductor chips for use in display and projection applications. The existing exemption now expires on 21 November 2025 and that for the new scope on 31 December 2027.
- 4. Member States have six months to put in place the updated exemption after the Directive comes into force, which is 20 days after its publication in the Official Journal. The Directive was published in the Official Journal on 21 May 2024.

SCRUTINY HISTORY

5. RoHS Directive exemptions are subject to regular updates. There is, however, no prior history relevant to this particular exemption. The Parliament Scrutiny history relating to earlier Explanatory Memoranda is contained in Annex A.

MINISTERIAL RESPONSIBILITY

6. Responsibility lies with the Secretary of State for Environment, Food and Rural Affairs.

INTEREST OF THE DEVOLVED ADMINISTRATIONS

7. Technical standards on the RoHS Directive and related Commission Delegated Directives are reserved policy. The Scottish and Welsh Governments and the Northern Ireland Executive have an interest due to the environmental considerations. The devolved governments have been consulted in the preparation of this Explanatory Memorandum and had no comments.

LEGAL AND PROCEDURAL ISSUES

8.

i. Legal Base

The power to make this Delegated Act is conferred by Article 5(1)(a) of the RoHS Directive, following the procedure set out in Article 20 and subject to the conditions laid down in Articles 21 and 22 of that Directive.

ii. Voting Procedure

The Delegated Act will enter into force (following publication in the Official Journal) only if no objection has been expressed either by the European Parliament or the Council within a period of two months of notification to the European Parliament and the Council or if, before the expiry of that period, the European Parliament and the Council have both informed the Commission that they will not object. That period shall be extended by two months at the initiative of the European Parliament or of the Council.

iii. Timetable for adoption and implementation

The Delegated Act was adopted by the Commission on 13 March 2024 and published in the Official Journal on 21 May 2024. It entered into force on the 20th day following publication with Member States needing to apply the amendments contained in the Delegated Act six months after the entry into force date.

POLICY AND LEGAL IMPLICATIONS

- 9. In order to facilitate dual access to both the UK Internal Market and EU Single Market, Northern Ireland applies certain EU regulations in accordance with the terms of the Windsor Framework. The RoHS Directive is listed in Annex 2 of the Windsor Framework, meaning Northern Ireland will apply this regulation.
- 10. However, no amending legislation is required to comply with this Delegated Act and no new burdens arise for businesses based in NI. This is because the process of due diligence required by businesses in NI to ensure compliance with their obligations under the RoHS Regulations, has not changed. Accordingly, the legislation in question is expected to have limited (if any) impact in practice in Northern Ireland.
- 11. As previously noted, the EU exemption applications were made some time ago and prior to Implementation Period completion day. Accordingly, entry 52 to Table 1 of Schedule A2 of the Restriction of the Use of Certain Hazardous Substances in Electrical and Electronic Equipment Regulations 2012 shows this exemption as a transitional case. Regulation 10 of the Hazardous Substances and Packaging (Legislative Functions and Amendment) (EU Exit) Regulations 2020 sets out the process for considering transitional cases.

CONSULTATION

12. The European Commission has undertaken formal consultation before reaching a determination on this application for exemption.

FINANCIAL IMPLICATIONS

13. There are no new financial implications arising from this Delegated Directive.
