Government response to Animal Sentience Committee: Animals Low-welfare Activities Abroad Act report

This is the Government's formal response to the Animal Sentience Committee's Animals (Low Welfare Activities Abroad) Act report published on 19 February 2024. We express our thanks to the committee for their engagement and assessment.

The Animals (Low Welfare Activities Abroad) Act 2023 received Royal Assent and passed into law in September 2023. The 2023 Act provides a framework for the introduction of a future bans on the advertising and offering for sale, in England and Northern Ireland, of low-welfare animal activities abroad. It is an important step in protecting animals from considerable suffering and unacceptable practices.

We are pleased to note that the committee is satisfied that there are no significant negative implications or animal welfare impacts in respect of the proposed legislation. We welcome their view, that the intentions of this Act should have a beneficial outcome on animal welfare.

Future decisions on which specific animal activities will fall in scope of the advertising ban will be evidence-based and subject to Parliamentary scrutiny. Sufficient, compelling evidence will be required to demonstrate why any specific advertising ban is needed. Relevant stakeholder engagement will be undertaken when developing future bans.

We are considering the most effective ways to deliver these commitments and will be setting out next steps in due course.
