DECISION

The sum of **£288** per calendar week will be registered as the fair rent with effect from **19th September 2024** being the date the Tribunal made the Decision.

SUMMARY REASONS

Background

1. Following an objection from the Tenant to the determination of a fair rent by the Rent Officer, the Tribunal has made a determination under the provisions of the Rent Act 1977.

Evidence

3. The Tribunal has consideration of the written submissions from the Tenant. Neither party provided the Tribunal with evidence of rental levels for comparable properties in the area.

Determination and Valuation

4. Having consideration of our own expert, general knowledge of rental values in the Paddington area together with the Landlords comparable evidence, we consider that the open market rent for the property in its current condition would be in the region of **£554** per week. (£2,400 per month) From this level of rent we have made adjustments in relation to: no white goods, no carpets or curtains, tenants improvements including double glazing, kitchen and sanitary fittings and terms of the tenancy which equates to approximately **35%**

5. The Tribunal has also made an adjustment for scarcity at **20%**

6. The full valuation is shown below:

7. **The Tribunal determines a rent of £288 per calendar week**

Decision

8. The uncapped fair rent initially determined by the Tribunal, for the purposes of section 70, was **£288** per week. The capped rent for the property according to the provisions of the Rent Acts (Maximum Fair Rent) Order 1999 is calculated at **£313** per calendar week. The calculation of the capped rent is shown on the decision form. In this case the lower rent of **£288** per week is to be registered as the fair rent for this property effect from 19th September 2024 being the date the Tribunal made the Decision.
