Colour of frame and spandrels to be dark grey. Locations to proposed aluminium frame single external doors to curtain walling to match existing. Door frame to match existing mullion widths and profiles. Colour to be dark grey.

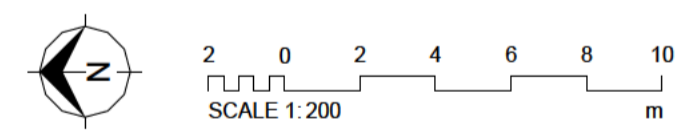

 - All proposed doorsets, window and curtain walling framing colours to be dark grey. Proposed spandrels to be dark grey to match proposed framing.
 - All proposed window and curtain wall systems to have fixed frames. Glazing & door system sizing, setting out, profiles and framing design are to match existing where possible.
 - All proposed glazing systems to be thermally broken complete with EPDM's sealed back to VCL/ masonry to form air tight line.
 - Existing Louvres are to be retained and repainted in colour dark grey.
 - Changes to interior (including layout configuration and other alterations) are internal to the building and therefore planning permission is not required. Details are provided for information only.
