Converter academy orders

Points discussed in relation to school conversion.

Project: To discuss Red Hall Primary School, Darlington, to convert and join The Education Village Academy Trust (EVAT).

AB discussion:

- The board agreed that the school and trust offer a strong match, provides a good link between the primary and secondary feeder school and is in line with the local area need.
- The board agreed that the current trust governance structure is strong, however they recommended that the trust considers recruiting additional primary and secondary expertise to strengthen the board further.
- The board is aware that EVAT has increased its capacity to develop their school improvement support for primary schools.
- The board agreed with the proposal of a SRMA deployment within 3 months of Red Hall joining EVAT.
- The RD approved this decision and agreed that the SRMA should be deployed within 3 months of Red Hall joining the trust.

- The board referred to the trust governance structure and suggested appointing two additional members, the board previously recommended some educational expertise including pupil premium, SEND and /or EHCP experience. The board would also benefit from a trustee with practical experience of working / leading a school.

• The RD approved this decision with recommendation that the trust reviews its governance and considers appointing additional members / trustees to strengthen its board.
