# The Historic Environment (Wales) Act 2023

#### The Historic Environment (Wales) Act 2023 came into effect on 4 November 2024.

The Act consolidates the existing primary legislation for the historic environment of Wales - principally the Ancient Monuments and Archaeological Areas Act 1979 and the Planning (Listed Buildings and Conservation Areas) Act 1990.

The Act improves the accessibility of Welsh law by incorporating some well-established subordinate legislation and elements of case law. From 4 November, originating authorities in Wales will need to consider the contents of the Act when registering local land charges.

### Collaborating with the Ministry of Housing, Communities and Local Government

We are working across government and with private sector organisations to share best practice, knowledge and data, to improve efficiencies. Together with the Ministry of Housing, Communities and Local Government's (MHCLG) Digital Planning Programme, we are using lessons learnt to reduce duplication of work.

In a recent weekly bulletin, they explained how this collaborative work and data sharing is benefitting local authorities:

"MHCLG Digital Planning Programme and HM Land Registry's (HMLR) Local Land Charges (LLC) Programme currently require local authorities to standardise some of the same data to increase efficiency in key housing and planning processes. As more local authorities have joined Digital Planning, we recognised many are also working on the LLC Programme. This means they are having to undertake similar activities to meet the needs of each programme. Obviously, we're keen to lead by example and ensure that local authorities don't have to work inefficiently on the journey to efficiency!

We have been engaging with HMLR to align ways of working and consider what would help the process for local authorities. We have recently drafted a Memorandum of Understanding with HMLR, to lay the foundations for data sharing between the two programmes, through closer alignment of technical specifications and data sharing processes. We're excited about this first step, and we'll be testing our approach with local authorities through joint events with HMLR in November". We have 150 delegates already signed up for these joint events. We have also identified seven migrated local authorities working on Digital Planning to join the workshops in November.

### Increasing customer satisfaction with continuous improvement

In May 2024, we introduced improvements to the map page results on Search for local land charges following customer feedback. **Changes to the layout** and accessibility mean searches are simpler and more intuitive. These changes combined with the efforts to improve services have resulted in a dramatic upward shift in our quarterly survey results.

In July, the **Customer Heartbeat Survey** that registers customer satisfaction across the breadth of HM Land Registry services, **recorded an increase of 17% for Local Land Charges**. This level of increase to ratings in a single quarter is very uncommon.

We are delighted that the work we are undertaking is having a positive impact on customers. And we are committed to ensuring that future developments continue to add real value to our service and are driven by user needs.





## The national LLC Register cost savings

Since programme launch, the LLC Register has recorded a total cost saving of over £2.5 million from searches with customers in migrated areas, saving an average of 12.7 days to obtain an LLC search result. More than 6 million charges from the 103 local authorities that have been migrated to the register.
