# **Non-Technical Summary**

This Noise and Vibration Monitoring Report fulfils HS2 Limited's commitment detailed in the Environmental Minimum Requirements (EMRs), Annex 1, Code of Construction Practice, to present the results of noise and vibration monitoring carried out within West Northamptonshire District Council (WNDC) area during the month of September 2024.

Within this period noise monitoring was undertaken in the vicinity of the following worksites:

- Fir Tree Nursery Worksite (ref.:FTN) where topsoil stripping, stockpile management, site access road maintenance, haul road operation, material movements, drainage and temporary pond works, water management, and vegetation and ditch maintenance were underway.
- Lower Boddington Worksite (ref.:LB) where topsoil stripping, stockpile management, site access road maintenance, haul road operation, material movements, drainage, water management, viaduct construction, bulk excavation, and vegetation and ditch maintenance were underway.
- Chipping Warden Worksite (ref.: CW) where Green tunnel erection and maintenance, bulk earthworks, site access road maintenance, haul road operation, material movements, batching plant operation, general maintenance, stockpile management, water management and material processing were underway.
- Blackgrounds worksite (ref.: BG) where topsoil stripping, stockpile management, site access road maintenance, haul road operation, material movements, drainage, water management and vegetation and ditch maintenance were underway.
- Lower Thorpe worksite (ref.: LT) where topsoil stripping, stockpile management, site access road maintenance, haul road operation, material movements, drainage and water management were underway.
- Greatworth worksite (ref.: GW) where stockpile management, site access road maintenance, haul road operation, material movements, drainage, utility diversion works, Bulk excavation and pier and structures construction were underway.
- Radstone and Hall Farm worksites (ref.: RA and ref.: HF) where stockpile management, site access and haul road maintenance and operation, bulk excavation, drainage, and concrete pours were underway.

Further works, where monitoring did not take place, were also undertaken at:

• A43 Compound where workshop building erection, de-vegetation and tree planting were underway.

• Helmdon Embankment where site access road construction was underway.

The HS2 threshold levels for significant noise impacts, which are defined in Information Paper E23 (<u>https://www.gov.uk/government/publications/hs2-information-papers-environment</u>), were not exceeded during the reporting period.

There were no exceedances of trigger levels as defined in Section 61 consents during the reporting period at any monitoring position.

No complaints were received during the monitoring period.

# 1 Introduction

- 1.1.1 HS2 is required to undertake noise (and vibration) monitoring as necessary to comply with the requirements of the High Speed Rail (London-West Midlands) Environmental Minimum Requirements, including specifically Annex 1: Code of Construction Practice, in addition to any monitoring requirements arising from conditions imposed through consents under Section 61 of the Control of Pollution Act, 1974 or through Undertakings & Assurances given to third parties. Such monitoring may be undertaken for the following purposes:
  - monitoring the impact of construction works;
  - to investigate complaints, incidents and exceedance of trigger levels; or
  - monitoring the effectiveness of noise and vibration control measures.
- 1.1.2 Monitoring data and interpretive reports are to be provided to each relevant local authority on a monthly basis and shall include a summary of the construction activities occurring, the data recorded over the monitoring period, any complaints received, any periods in exceedance of agreed trigger levels, the results of any investigations and any actions taken or mitigation measures implemented. This report provides noise data, and interpretation thereof, for monitoring carried out by HS2 within the West Northamptonshire District Council (WNDC) area for the period 1<sup>st</sup> to 30<sup>th</sup> September 2024.
- 1.1.3 Active construction sites in the local authority area where monitoring was undertaken during this period include:
  - Fir Tree Nursery worksite, ref.: FTN (see Works Identification Plan 1 in Appendix A), where the following work activities were undertaken:
    - Topsoil stripping.
    - Stockpile management.
    - Site access road maintenance.
    - Haul road operation, including material movements.
    - Drainage.
    - Water management, including temporary ponds.
    - Vegetation maintenance.
    - Ditch maintenance.
  - Lower Boddington worksite, ref.: LB (see Works Identification Plan 1 in Appendix A), where the following work activities were undertaken:
    - Topsoil stripping.

- Stockpile management.
- Site access road maintenance.
- Haul road operation, including material movements.
- Drainage.
- Water management, including temporary ponds.
- Vegetation maintenance.
- Viaduct construction.
- Bulk excavation of cutting.
- Ditch maintenance.
- Chipping Warden worksite, ref.: CW (see Works Identification Plan 2 in Appendix A), where the following work activities were undertaken:
  - Green tunnel erection and maintenance.
  - Bulk earthworks.
  - Site access road maintenance.
  - Haul road operation, including material movements.
  - Batching plant operation.
  - General site operation, including vegetation, compound, ditch and plant maintenance.
  - Stockpile management.
  - Water management, including temporary pond installation.
  - Material processing.
- Blackgrounds worksite, ref.: BG (see Works Identification Plan 2 in Appendix A) where the following work activities were undertaken:
  - Topsoil stripping.
  - Stockpile management.
  - Site access road maintenance.
  - Vegetation maintenance.
  - Haul road operation, including material movements.
  - Drainage.
  - Water management, including temporary ponds.
  - Ditch maintenance.

- Lower Thorpe worksite, ref.: LT (see Works Identification Plan 3 in Appendix A), where the following work activities were undertaken:
  - Topsoil stripping.
  - Stockpile management.
  - Site access road maintenance.
  - Haul road operation, including material movements.
  - o Drainage.
  - Water management, including temporary ponds.
- Greatworth, ref.: GW (see Works Identification Plan 4 in Appendix A) where the following work activities were undertaken:
  - Stockpile management.
  - Site access road maintenance.
  - Haul road operation, including material movements.
  - Drainage.
  - Water management, including temporary ponds.
  - Utility diversion works.
  - Bulk excavation.
  - Pier construction.
  - Structures construction.
- Radstone and Hall Farm worksites, ref.: RA and ref.: HF (see Works Identification Plan 5 in Appendix A) where the following work activities were undertaken:
  - Stockpile management.
  - Site access and haul road maintenance and operation.
  - Bulk earthworks.
  - Drainage.
  - Concrete pouring.
- 1.1.4 Further works, where monitoring did not take place, were also undertaken at:
  - A43 Compound where workshop building erection, de-vegetation and tree planting were underway.
  - Helmdon Embankment where site access road construction was underway.

### **1.2 Measurement Locations**

- 1.2.1 Nine (9) noise monitoring installations were active in September in the WNDC area.

# 2 Summary of Results

### 2.1 Summary of Measured Noise Levels

2.1.1 Table 3 presents a summary of the measured noise levels at each monitoring location over the reporting period. The L<sub>Aeq,T</sub> is presented for each of the relevant time periods averaged over the calendar month, along with the highest single period L<sub>Aeq,T</sub> that was found to occur within the month.

2.1.2 Appendix C presents graphs of the noise monitoring data over the month for each of the measurement locations. Noise data presented consists of the hourly L<sub>Aeq</sub> values and, where relevant, the L<sub>Aeq,T</sub> values (where the time period T has been taken to be the averaging period as specified in Table 1 of HS2 Information Paper E23). ### 2.2 Exceedances of the LOAEL and SOAEL

- 2.2.1 The lowest observed adverse effect level (LOAEL) is defined in the Planning Practice Guidance – Noise (PPG) as the level above which "noise starts to cause small changes in behaviour and/or attitude, e.g. turning up volume of television; speaking more loudly; where there is no alternative ventilation, having to close windows for some of the time because of the noise. Potential for some reported sleep disturbance. Affects the acoustic character of the area such that there is a perceived change in the quality of life".
- 2.2.2 The significant observed adverse effect level (SOAEL) is defined in the 'Planning Practice Guidance – Noise' as the level above which "noise causes a material change in behaviour and/or attitude, e.g. avoiding certain activities during periods of intrusion; where there is no alternative ventilation, having to keep windows closed most of the time because of the noise. Potential for sleep disturbance resulting in difficulty in getting to sleep, premature awakening and difficulty in getting back to sleep. Quality of life diminished due to change in acoustic character of the area."
- 2.2.3 HS2 Phase One Information Paper E23: Control of Construction Noise and Vibration sets out the LOAELs and SOAELs for construction noise.
- 2.2.4 Where reported construction noise levels exceed the LOAEL and SOAEL, relevant periods will be identified. Summary statistics to evaluate ongoing qualification for noise insulation and temporary rehousing are also presented where relevant.
- 2.2.5 Table 4 presents a summary of recorded exceedances of the LOAEL and SOAEL at each measurement location over the reporting period, including the number of exceedances during each time period.

2.2.6 Exceedances of the LOAEL were recorded at five (5) monitoring locations during the month of September 2024. LOAEL exceedances were recorded during weekday, Saturday and Sunday daytime periods.

2.2.7 No SOAEL exceedances were recorded due to HS2 construction works during September 2024.

### 2.3 Exceedances of Trigger Level

2.3.1 Table 5 provides a summary of exceedances of the Section 61 trigger noise levels determined to be due to HS2 related construction noise measured during the reporting period, along with the findings of any investigation.


















## HS2 Noise Monitoring Plan - 4











