

Funding Rules 2015 to 2016 Version 2 Addendum 2

Introduction

- 1. This document sets out an amendment to Funding Rules 2015 to 2016 Version 2.
- 2. The amendment forms part of the terms and conditions of the funding agreements and the Advanced Learning Loans Facility Conditions between the Secretary of State for Business, Innovation and Skills acting through the Skills Funding Agency (SFA) and all providers of education and training who receive funding from the SFA or an Advanced Learning Loan (Loan) Facility.
- 3. The amendment changes the funding rules on English and maths in apprenticeships.
- 4. We will apply the change to the funding rules from **1** August 2015.

New paragraph inserted	Where an apprentice has achieved a level 2 qualification in English or maths, before starting an apprenticeship which specifies this level of qualification, irrespective of when this was achieved, we would not expect further funded learning in English or maths to achieve their apprenticeship framework. However, if the following conditions apply you can offer further learning to meet the level of skills needed to achieve their framework if they are assessed at below level 2.
