The Electricity (Individual Exemption from the Requirement for a Transmission Licence) (Dogger Bank A) (England) Order 2025

Laid before Parliament	***
Coming into force	10th February 2025

The Secretary of State makes the following Order in exercise of the powers conferred by section 5(1) of the Electricity Act 1989(**a**).

The Secretary of State has given notice of the proposal to make this Order in accordance with section 5(2) and (3) of that Act, and has considered any representations made.

Citation, commencement, extent and application

1.—(1) This Order may be cited as the Electricity (Individual Exemption from the Requirement for a Transmission Licence) (Dogger Bank A) (England) Order 2025 and comes into force on 10th February 2025.

- (2) This order extends to England and Wales and Scotland.
- (3) This order applies in relation to England only.

Exemption from section 4(1)(b) of the Electricity Act 1989

2.—(1) The Secretary of State grants exemption from section 4(1)(b) of the Act(**b**) (prohibition on unlicensed transmission of electricity for supply) to Doggerbank Offshore Wind Farm Project 1 Projco Limited in respect of transmission(**c**) taking place over the transmission system(**d**) connected to the Dogger Bank A Offshore Wind Farm.

(2) The exemption in paragraph (1) applies for the period beginning with 10th February 2025 and ending with the earlier of—

- (a) the day after the day on which the transmission system connected to Dogger Bank A Offshore Wind Farm is transferred to a successful bidder(a);
- (b) 19th December 2025.

(3) In this article—

- (a) "the Act" means the Electricity Act 1989;
- (b) "Dogger Bank A Offshore Wind Farm" means the generating station located approximately 100 kilometres from the shore, in the North Sea and off the Yorkshire coast, its coordinates at its central point being Latitude 54° 46.995 and Longitude 1° 51.268.
- (c) "Doggerbank Offshore Wind Farm Project 1 Projeco Limited" means Doggerbank Offshore Wind Farm Project 1 Projeco Limited, a company registered in England and Wales with the company number 07791991.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order grants exemption from the requirement to hold an electricity transmission licence.

Section 4(1)(b) of the Electricity Act 1989 (c. 29) prohibits the transmission of electricity for supply without a licence. The Secretary of State, exercising the powers under section 5(1) of that Act, grants a time limited exemption from the requirement to hold a transmission licence to Doggerbank Offshore Wind Farm Project 1 Projco limited in respect of the Dogger Bank A Offshore Wind Farm.

A full impact assessment has not been produced for this instrument as it is a temporary measure. No, or no significant, impact on the private, voluntary or public sector is foreseen.
