## North Yorkshire and Norther Humberside

### Converter academy orders

**Project: An application from Applefields School, York, to convert and become an academy and join Pathfinder Multi Academy Trust.**

**Representations received:**

- No representations were made for any items discussed at this meeting.

**AB discussion:**

- Applefields School is a 221 place 11-19 special school in York, catering for pupils with a wide range of Special Educational Needs and Disabilities (SEND); this includes those pupils with autism, those with severe learning disabilities, those with profound and multiple learning disabilities and those with social, emotional and mental health (SEMH) needs. All pupils have an Education, Health and Care Plan (EHCP).
- Officials' assessment of the trust using the Commissioning High Quality Trusts Framework was considered alongside Applefields School's strategic needs. In making the recommendation, consideration was given to the existing relationship with the trust and the strengths that the school and trust can bring to each other.
- The board members considered the details of the project and support the recommendation to approve. The project makes geographical sense, and the proposal would bring benefits to both parties.

### Trust Changes

**Project: A proposal for South Craven School, North Yorkshire, to transfer from South Craven Academy Trust to The Pennine Trust.**

**Representations received:**

- No representations were made for any items discussed at this meeting.

**AB discussion:**

- South Craven School (SCS) is the only school in the South Craven Academy Trust which was established in 2011. The school is situated between Skipton and Keighley in North Yorkshire. It is an 11-18 secondary which was judged as good by Ofsted in February 2023 and is consistently over capacity.

- Officials' assessment of the trust using the Commissioning High Quality Trusts Framework was considered alongside South Craven School's strategic needs. In making the recommendation, it was considered that both the school and the trust would benefit from working together.
- The board members considered the details of the project and support the recommendation to approve. The project makes geographical sense, and both parties would be stronger as a result of approval. Board Members also recommended a School Resource Management Advisor (SRMA) deployment to the trust post transfer.

### Converter academy orders

**Project: An application from Hunslet Carr Primary School, Leeds, to convert and become an academy and join Cockburn Multi Academy Trust.**

**Representations received:**

- No representations were made for any items discussed at this meeting.

**AB discussion:**

- Hunslet Carr Primary School (HCPS) 3-11 community school located in Hunslet, Leeds with 406 pupils on roll and a capacity of 420. The school was last inspected in November 2021 and is currently rated as Good.
- Officials' assessment of the trust using the Commissioning High Quality Trusts Framework was considered alongside Hunslet Carr Primary School's strategic needs. In making the recommendation, consideration was given to the fact HCPS and the trust have visions and values that are closely aligned, they have some similarities in terms of the demographics of cohorts and the project makes geographical sense.
- Regional Director would like to see more detail of the Trust's Primary School Improvement Strategy.
- This item was considered along the proposal for Cockburn Multi Academy Trust to sponsor Ingram Road Primary School, Leeds

**Project: An application from Spring Grove Junior, Infant and Nursery School, Kirklees, to convert and become an academy and form a new trust called Heritage Multi Academy Trust.**

**Representations received:**

- No representations were made for any items discussed at this meeting.

**AB discussion:**

- Spring Grove Junior, Infant and Nursery School is a 210 capacity school located in Kirklees with 229 pupils on roll. The school was last inspected in March 2015 and is currently rated as Outstanding. The school was previously designated a National Support School and in 2022 was appointed as a Behaviour Hub.
- This item was considered along with 3 other schools (Moorlands Primary School, Reinwood Community Junior School and Reinwood Infant and Nursery School) and 2 Single Academy Trusts (Salendine Nook High School Academy and Lindley Junior School) forming a new Multi Academy Trust in Kirklees.
- Officials' assessment of the trust using the Commissioning High Quality Trusts Framework was considered alongside Spring Grove Junior, Infant and Nursery School's strategic needs. In making the recommendation, consideration was given to the existing strengths of and proximity of the schools in the proposal.
- The board members considered the details of the project and support the recommendation to approve. The project makes geographical sense, and board members were assured by the clear plan for the formation of the Multi Academy Trust which gave board members assurance.

- Moorlands Primary School is a 630 capacity school located in Kirklees with 627 pupils on roll. The school was last inspected in February 2024 and is currently rated as Good.

- This item was considered along with 3 other schools converting (Spring Grove Junior, Infant and Nursery School, Reinwood Community Junior School and Reinwood Infant and Nursery School) and 2 Single Academy Trusts (Salendine Nook High School Academy and Lindley Junior School) forming a new Multi Academy Trust in Kirklees.
- Officials' assessment of the trust using the Commissioning High Quality Trusts Framework was considered alongside Moorlands Primary School strategic needs. In making the recommendation, consideration was given to the existing strengths of and proximity of the schools.

- This item was considered along with 3 other schools (Spring Grove Junior, Infant and Nursery School, Moorlands Primary School and Reinwood Infant and Nursery School) and 2 Single Academy Trusts (Salendine Nook High School Academy and Lindley Junior School) forming a new Multi Academy Trust in Kirklees.

In making the recommendation, consideration was given to the existing long standing relationship between the school and proposed sponsoring trust, the similarities in the demographics of cohorts and of the close geographical proximity.
- Board Members would like to see more detail of the Trust's Primary School Improvement Strategy.
- This item was considered along with the application from Hunslet Carr Primary School, Leeds, to convert and become an academy and join Cockburn Multi Academy Trust..

- This item was considered along with 3 other schools (Airedale Junior School, Airedale Infant School and Oyster Park Primary School) all transferring from Northern Ambition Academies Trust to join Castleford Academy Trust (CAT). Approval would result in the closure of Northern Ambition Trust.
