With the agreement of the importing country, meat products may also include the following commodities:

[•] Offal: fresh meat other than that of the carcase, including viscera and blood;

[•] Meat preparations: fresh meat, including meat that has been reduced to fragments, which has had foodstuffs, seasonings or additives added to it, e.g. sausages, burgers;

Minced meat: boned meat that has been minced into fragments and contains less than 1% salt.
