**references to standards for personal protective equipment in support of  
Regulation 2016/425 on personal protective equipment as it has effect in  
domestic law**

1. This notice sets out proposals that:
  - (a) The references to the standards listed in Annex I to this notice be published for the purposes of Article 7A of Regulation 2016/425 in accordance with paragraph (2) below, and that the list of published standards set out in Part 2 of Annex I to notice 0096/24 be amended in accordance with Annex I to this notice.
  - (b) The references to the standards listed in Annex II to this notice (which have previously been published for the purposes of Article 7A of Regulation 2016/425), be removed from publication from the date set out in that Annex and the list of references for removal from publication set out in Annex II to notice 0096/24 be amended in accordance with Annex II to this notice. Accordingly, the standard will not be designated, or give rise to any presumption of conformity, on or after the removal from publication date set out in respect of it.
2. The reference to the standard is proposed to be published and accordingly designated under Article 7A of Regulation 2016/425 at 00.01 on the 29th day beginning with the date of this notice, unless this notice is withdrawn or amended before that date. ## ANNEX II
