**references to standards for electrical equipment designed for use within
certain voltage limits in support of the Electrical Equipment (Safety)
Regulations 2016 (S.I. 2016/1101)**

1. This notice sets out proposals that:
 - (a) The references to the standards listed in Annex I to this notice be published for the purposes of regulation 2A of S.I. 2016/1101 in accordance with paragraph (1) of Annex I below; and that the list of published standards set out in Part 2 of Annex I to notice 0106/24 be amended in accordance with Annex I to this notice.
 - (b) The references to the standards listed in Annex II to this notice (which have previously been published for the purposes of regulation 2A of S.I. 2016/110) be removed from publication from the date set out in that Annex and the list of references for removal from publication set out in Annex II to notice 0106/24 be amended in accordance with Annex II to this notice. Accordingly, the standard will not be designated, or give rise to any presumption of conformity, on or after the removal from publication date set out in respect of it.
2. The list of references to standards designated under regulation 2A of S.I. 2016/1101 are proposed to be amended at 00.01 on the 29th day beginning with the date of this notice, unless this notice is withdrawn or amended before that date.
