Diplomacy

Supported UNGA resolutions condemning Russia's: invasion [Mar 22, Feb 23]; attempted annexation of 4 Ukrainian regions [Oct 22]; & attacks on Ukraine's energy infrastructure [Jul 24]

We use the UNSC to hold Russia to account & reaffirm support for Ukraine. FS used Presidency to mark 1000 days of invasion [18 Nov]

At OSCE, we call out Russia weekly & co-fund Support Programme for Ukraine. 4 fact-finding missions reported on human rights abuses.

At Annual Ministerial Council we called for increased support [6 Dec] At IAEA, we support efforts towards nuclear safety in Ukraine

Military

£7.8bn total support, including £3bn for 2024/25

Commited £3bn a year until 2030/31 & for as long as it takes [10 Jul] £2.26bn contribution to G7 ERA Loans, to be repaid using profits

generated by Russian assets. HMG laid legislation [6 Nov] to facilitate disbursement

Sent approx. 400 different capabilities to Ukraine incl. new £225m package incl. drones, boats & munitions [19 Dec], 650 LMM missiles [6 Sep] & package of military equipment [7 Jul]

£7.5m of funding for new attack & surveillance drones, invested via UK and Latvia-led drone coalition [19 Nov]

A new UK/Ukraine Defence Industrial Support Treaty expands the range of military equipment that can be funded via £3.5bn of UK Export Finance-guaranteed loans [19 Jul]

Over 51,000 Ukrainian personnel trained under Operation INTERFLEX. Scheme extended until at least end 2025 [6 Sep]

UK-administered International Fund for Ukraine procures military equipment: >£1.3bn has been pledged to date [11 Sep], including for a new £300m ammunition order [10 Jul]

Non-military

£5bn in non-military commitments since Feb 22. This includes:

- £4.1bn in fiscal support through World Bank loan guarantees
- £977m in bilateral assistance. £282m in 2024/25 funds reform, humanitarian, energy, recovery & reconstruction programmes

Humanitarian

£477m total assistance to Ukraine and the region, incl. at least £120m in humanitarian assistance in 2024/25 [11 Sep]

£15m will support those most in need this winter [17 Dec]

We have provided £8.6 million to HALO Trust for demining. Over 350,000m² land cleared (May 22 to Sep 24)

Recovery & Reconstruction

Co-hosted Ukraine Recovery Conference 2023, raising over \$60bn

War risk insurance via MIGA & EBRD boosts inward investment

To date UK Export Finance has issued over £500m in support of critical reconstruction, energy and defence projects

Through our Development Finance Institution, British International Investment, working with the EBRD to make trade finance available to support critical imports/exports. BII to provide up to £30m [11 Sep]

UK Good Governance Fund for Ukraine, a £38m 3-year technical assistance programme, counters corruption and supports reform

Energy

Over £390m for energy security and resilience through grant, in-kind support and loan guarantees

A further £20m to support emergency energy needs takes total support to the Ukraine Energy Support Fund to £84m [17 Dec]

£181m from UKEF for Urenco to supply enriched uranium [18 Jul]

£16m to support UK and Ukrainian innovators through UK's Innovate Ukraine Green Energy Competition [2 May]

Supporting the supply of vital nuclear fuel to power Ukraine & maintain its independence from Russian fuel

Sanctions

>2,100 individuals and entities sanctioned, incl. 1,900 since full-scale invasion

UK, US and EU sanctions have deprived Russia of over \$400bn since Feb 2022 - equivalent to 4 more years funding for the invasion

Since imposition of Oil Price Cap, Russian data shows a 30% reduction in tax revenues from oil in 2023, compared to year before

IMF forecasts reduction in growth from 3.6% in 2024 to 1.3% in 2025

This Government has imposed sanctions against:

- over 100 ships. Announced sanctions on 20 more tankers in Putin's Shadow Fleet & 2 entities responsible for this reckless trade [17 Dec]

- those forcibly deporting & indoctrinating children [19 Nov]

 Russia's military industrial complex & Private Military Security groups: 56 new sanctions, largest package since May 2023 [7 Nov]
