# Sponsored academy orders

# Project: A proposal for James Brindley School Trust to sponsor Oscott Manor School, Birmingham.

#### **Representations received:**

• No representations were made for any items discussed at this meeting.

- Oscott Manor School, Birmingham is an Ofsted rated "Inadequate" school who require a sponsor to develop improved school outcomes.
- James Brindley School Trust is a special school in Birmingham which caters for ages 2 to 19 and a range of SEND needs including SEMH, ASC and hospital provision. The school operates in 11 sites across the city: 3 school centres and 8 hospital/clinic locations. Due to the multiple sites, the SAT operates on a similar model to a MAT with a large central leadership team.

- This SAT is therefore applying to form a MAT to be known as Think Differently Multi-Academy Trust to take on Oscott Manor School as a sponsor project.
- James Brindley Schools Trust is a SAT that has 3 school settings within Birmingham one of which Dovedale is 1.4 miles from Oscott Manor and one of its hospital settings, Ardenleigh is just 0.9 miles from the school.
- James Brindley School Trust has a clear and detailed SI Plan detailing areas that would benefit Oscott Manor, including SI Strategies, Track record, Finance, and Leadership & Governance. The Trust has capacity to grow and add additional resource to the Special school provision in Birmingham.
- The board discussed school improvement and trust board capacity, expansion and provision, and the trusts governance and finances.

- St. John Paul II Multi Academy Company consists of 9 academies across Birmingham.
- St John Paul II Multi Academy Company (SJP II MAC) was highlighted as a potential trust, due to it having multiple statistical neighbours in the local area, and above national and local average of pupils achieving expected standard in Reading, Writing and Maths. This is a voluntary conversion and SJP II MAC is the school's preferred trust, due to shared ethos and values.
- Regarding their Catholic life, SJPII MAC see this as an opportunity to strengthen their practice through joint sacramental preparation, retreats, schemes of work etc. They also see the increased collaboration between schools as an opportunity to enhance standards in teaching and learning through shared CPD, assessment, work scrutiny, moderation, and cross phase(primary/secondary) challenge. Part of their future vision also includes developing a SJPII MAC brand of education that motivates and challenges young people.

- The vision for the MAC has resulted in them making some major changes to how schools are funded and the appointment of a school improvement lead for inclusion, both of which are giving the trust greater capacity to deliver high quality school improvement support.

# Establishing a new academy through the free school presumption route

# Project: A proposal for a sponsor for Foxlydiate First School, Worcestershire.

#### **Representations received:**

• No representations were made for any items discussed at this meeting.

- The Foxlydiate area straddles the boundary between Bromsgrove and Redditch District Councils in the north of Worcestershire, within a locality that has attracted several housing developments in recent years.
- A major housing development on land to the west of Foxlydiate Lane and Pumphouse Lane is expected to deliver c. 2,560 new houses by 2037. This development is forecast to generate around 28 pupils in each year group of first school age (nursery and Reception through to Year 4) by 2027 and 73 pupils by 2031.

- There are also other developments in the locality which are forecast to generate a further 26 Reception age pupils by 2027 and 39 pupils by 2031. Existing local schools cannot be expanded to accommodate these numbers, so a new first school is required. The developer of Foxlydiate is providing a site within the development, which will enable these 113 pupils to access a first school within their local community, and they are contributing the majority of the construction cost.
- Worcestershire County Council has identified the need to establish a new First School in Foxlydiate to open in 2027.
- The school will open initially with a nursery and Reception Year cohort only, which will gradually feed through the school until reaching all year groups, allowing the number on roll to grow organically to reach capacity in 2031. The school site is of sufficient size to accommodate a three forms of entry school.
- The board supported this proposal.
