Dear I

Thank you for your email of 27 February 2024 to the Ministry of Defence (MOD), and your subsequent clarifications dated 19 March 2024, 2 April 2024 and 14 June 2024, requesting the following information:

"for each year from 2016 to 2023 by commitment type and rank. If it is not possible to do by rank could you please split by OR and OF.

- 1. How many FTRS contracts were extended? Both as a number and as a percentage of all contracts.
- 2. How many of those extensions were done so without competition?"

And

"OR - other ranks

OF - officers

FTRS - full time reserve service. To include full commitment (fc), limited commitment (lc) and home commitment (hc)"

And

"If possible I would like the requested information for Army, Navy and RAF.

If it is not possible to provide information for all three services I would be happy to reduce my request to just the Army."


And

"By percentage of all contracts I mean percentage of all FTRS contracts of the same commitment level.

For example if there were 100 FTRS (LC) contracts and 10 of those were extended I would expect the response to say 10%."

I am treating your correspondence as a request for information under the Freedom of Information Act 2000.

A search for the information has now been completed within the MOD and I can confirm information in scope of your request relating to Question 1 is held and shown at Annex A.



I can also confirm that the MOD holds no data in relation to your Question 2 as this information is not recorded on the Joint Personnel Administration (JPA) MI System.

Finally, in order to protect personal information governed by the Data Protection Act 2018, Section 40(2) of the FOI Act has been applied to some of the information by supplementing numbers of 5 or less with an [x]. Section 40 is an absolute exemption and there is therefore no requirement to consider the public interest in making a decision to withhold the information.


All numbers have been rounded separately, so the total, which has been rounded to the nearest five may not equal the sum of the parts.
