Applications can be submitted for one or both disease groups, with a discounted fee for combined applications. The Prices listed below are exclusive of VAT. - Listing is granted for 5 years, after which time it will be necessary to reapply for product listing using this form.

This privacy notice sets out what you can expect from Cefas when we process your personal information. This is complemented by our [personal information charter](#), which broadly sets out our standards for requesting or storing personal information.

What data do we collect?

The information that we collect from you includes:

- Name
- Address/Postcode
- Email address
- Telephone/mobile number
- Bank details for invoicing purposes

Why are we processing your personal data?

Any personal data supplied on the application form or provided separately by the client, in connection with this application is essential for Cefas to be able to contact you and process your application. The data will also be stored for the purpose of administering the disinfectant listings mechanism.

As the process involves input from third-party laboratories, we may also receive your personal information as they transfer certification and test details.

What is the legal basis for processing your personal data?

The General Data Protection Regulation (GDPR) Article 6 legal bases for processing your data are that it is necessary for the **performance of a contract**, and that the processing is necessary for the **performance of a task** in the public interest or in the exercise of official authority vested in the controller.
