

CHAPTER xxii

An Act to confirm a Provisional Order made by the Minister of Transport under the General Pier and Harbour Act, 1861, relating to Yarmouth (Isle of Wight). [29th July, 1960.]

HEREAS a Provisional Order made by the Minister of Transport under the General Pier and Harbour Act, 1861, is not of any validity or force whatever until confirmation thereof by Act of Parliament:

And whereas it is expedient that the Provisional Order made by the Minister of Transport under the said Act which, as amended, is set out in the schedule to this Act be confirmed by Act of Parliament:

Be it therefore enacted by the Queen's most Excellent Majesty by and with the advice and consent of the Lords Spiritual and Temporal and Commons in this present Parliament assembled and by the authority of the same as follows:—

- 1. The Order as set out in the schedule to this Act shall be Confirmation and the same is hereby confirmed and all the provisions thereof of Order in in manner and form as they are set out in the said schedule shall from and after the passing of this Act have full validity and force.
- 2. This Act may be cited as the Pier and Harbour Order Short title. (Yarmouth (Isle of Wight)) Confirmation Act, 1960.

SCHEDULE

YARMOUTH (ISLE OF WIGHT) PIER AND HARBOUR ORDER, 1960

Provisional Order to amend the Yarmouth (Isle of Wight) Pier and Harbour Order, 1931.

Short and collective titles.

- 1.—(1) This Order may be cited as the Yarmouth (Isle of Wight) Pier and Harbour Order, 1960.
- (2) The Yarmouth (Isle of Wight) Pier and Harbour Order, 1931 and this Order may be cited together as the Yarmouth (Isle of Wight) Pier and Harbour Orders 1931 and 1960.
- 2. This Order shall come into operation upon the day when the Commencement. Act confirming this Order is passed.
- 3. The Harbours Docks and Piers Clauses Act 1847 shall not be Exclusion of Harbours Docks incorporated with this Order. and Piers Clauses Act 1847. 10 & 11 Vict. c. 27.
