Thank you for your email of 4th April 2024 which contained your request for information. The Government Legal Department ("GLD") have processed your request for information under the Freedom of Information Act 2000 ("the Act")

Request

Further to my FOI requests dated 24 November 2023 and 12 December 2023 and GLD's response dated 16 January 2024 (all attached for ease of reference). In GLD's response dated 16 January 2024 it was said that: "We can confirm GLD intends to publish relevant information post implementation of the pay case."

The Pay Business Case data sets circulated by GLD on 27 March 2024 did not include answers to my requests dated 3, 4, 5, 6 and 9 contained in my requests dated 24 November 2023 and 12 December 2023. Accordingly, could you please therefore provide this information to me as a matter of urgency or let me know when it will be made available.

Response

Pursuant to Section 1(1)(a) of the Act, GLD informs you that it holds the information you have requested.

All information held which demonstrates whether the forecasting / modelling to be found at page 3 of GLD's Equality Impact Statement for the pay offer is accurate or not, namely: - that 84% of G7 & G6 lawyers are to receive at least 10%; - that over half are to receive over 19%; and - that 31% - those currently lowest on their scales – are to receive at least 23%.

The numbers shared in GLD's equality impact assessment were a forecast. This has now been re-run to show actuals, based on published outcomes - See table 3
