1. Full description and responsibilites of your job role for Ministry of Defence Police?

Freedom of Information Manager - Responsible for the management of all MDP Freedom of Information requests and drafting responses to meet statutory obligations.

2. Full details of your sworn Oath in order for to work for the Ministry of Defence Police?

No information held. The Freedom of Information Manager role is a non-uniformed role. MDP non-uniformed staff are Ministry of Defence civil servants and are not required to be attested.

3. Full details of the recent sworn Oath of a Police Constable representing Ministry of Defence Police?

All officers must be attested for the force they work in. The MDP attestation is as follows:

I do solemnly and sincerely declare and affirm that I will well and truly serve the King in the office of constable, with fairness, integrity, diligence and impartiality, upholding fundamental human rights and according equal respect to all people; and that I will, to the best of my power, cause the peace to be kept and preserved and prevent all offences against people and property; and that while I continue to hold the said office I will to the best of my skill and knowledge discharge all the duties thereof faithfully according to law.
