Welcome to DIO's monthly newsletter designed to provide families living in SFA with useful updates and information on their homes.

SFA Estate Development

You may have seen our <u>announcement</u> last month that a landmark deal was reached enabling the MOD to buy back 36,347 SFA homes in the UK, previously sold to Annington in 1996.

Now that we have renewed our ownership over thousands of homes, we are no longer held back by the restrictions we once were. This creates new opportunities to sell, redevelop and refurbish the estate. There are already two programmes of work in motion, with a planning application submitted for 265 new net-zero houses at RAF Brize Norton and a further application for 300 new houses at Catterick Garrison will be submitted in the spring.

A Defence Housing Review has been commissioned by the Secretary of State to determine how we can renew forces housing to meet modern consumer standards and how we can better exploit the potential of MOD land.

As part of the review, around 2,500 homes across the UK will be independently surveyed. This will help to provide a detailed assessment of the condition of SFA homes. Should your home be selected for inclusion in the survey programme, you will receive a letter approximately one week before the intended date of the inspection. Letters will be issued from Jones Lang LaSalle (JLL), who are undertaking the surveys for DIO.

Providing access for these surveys to take place will help us to make the best decisions on the future of the SFA estate, and we are grateful for your support in enabling access if your home is selected. More detail can be <u>found</u> <u>here.</u>

We appreciate that many of you may have questions about the announcement and this 'once in a generation' opportunity to transform the quality of SFA but change of this nature and scale will not happen overnight. We will continue to update you on the plans and development of the SFA estate over the coming months through this newsletter and our SFA Roadshows.

Brize Norton on Tuesday 4 March – 13:00hrs and 17:30hrs





Pinnacle Drop-in Sessions

In response to your feedback, DIO, Pinnacle, Amey and VIVO have opened local housing office drop-in sessions. The following locations are now available: Aldershot, Blandford, Brize Norton, Brompton, Colchester, Cosford, Gosport, Larkhill, Leuchars, Plymouth, Portsmouth, Waddington, Weeton and Windsor.

Afghan Relocation and Assistance Policy (ARAP) Update

Over the coming months there will be a change to the delivery of the Afghan resettlement scheme to a simpler and more cost-effective programme which will help deliver better outcomes overall.

ARAP is being replaced by the new Afghan Resettlement Programme (ARP) which is a joined-up delivery programme, that brings together the two existing Afghan resettlement schemes: Afghan Relocations and Assistance Policy (ARAP) and Afghan Citizens Relocation Scheme (ACRS).

Transitional accommodation will continue to be provided across the SFA estate, but the Government's aim is to return sites to their previous use, and every effort is being made to minimise any impact on Service Personnel and families whilst Local Authorities identify settled accommodation for Afghan families.

Raising repair tasks

A reminder that it is important to report any necessary repairs in your home even while you're in the process of moving out. This allows for any required work to be completed before a new family moves in, creating a smoother transfer for all.
