We are treating your email as a request for information in accordance with the Freedom of Information Act 2000 (FOIA 2000).

**I am looking to request information on the number of non-crime hate incidents recorded each year:**

**1. Please can you provide an annual breakdown of non-crime hate incidents (NCHIs) recorded for each year from 2014 (or earliest possible year) to 2024. For 2024, please provide up until the date of response.**

**2. Please can you provide an annual breakdown of the NCHIs recorded for each year from 2014 (or earliest possible year) to 2024 by characteristic (i.e. religion, race etc.). For 2024, please provide up until the date of response.**

A search for the information is complete and I can confirm that the MDP do hold information in scope of your request.

Due to a new system in place we can currently only search back to August 2021.
