^{[1] &}quot;Meat products" means processed products resulting from the processing of meat or from the further processing of such processed products, so that the cut surface shows that the product no longer has the characteristics of fresh meat. With the agreement of the importing country, meat products may also include the following commodities:

[•] Offal: fresh meat other than that of the carcase, including viscera and blood;

Meat preparations: fresh meat, including meat that has been reduced to fragments, which has had foodstuffs, seasonings or additives added to it, e.g. sausages, burgers;

ullet Minced meat: boned meat that has been minced into fragments and contains less than 1% salt.

* (d) Name, address and official approval number of the cold store: Destination of products (a) Name and address of exporter (b) Name and add nsignee (c) Name and address of premis despatch: (d) Means of transportation (Name of ship, number, airport/port of departure): Health Information IV I, the undersigned Official Veterinarian, certify that the meat/meat products described above meet the following conditions: *(i) for export of bovine, ovine and caprine meat - the meat/meat products were derived from animals which, at the time of their slaughter, were resident in a territory that has been free from rinderpest and foot and mouth disease (FMD) for the past 12 months; *(ii) for export of porcine meat - the meat/meat products were derived from animals which, at the time of their slaughter, were resident in a territory that has been free from rinderpest, FMD, African swine fever, swine vesicular disease and classical swine fever for the past 12 months; they originate from the United Kingdom and/or were legally imported into the (b) United Kingdom; they were derived from animals that have not been slaughtered for the purpos (c) disease eradication or disease control; (d) they were derived from animals that have been subjected to satisfactory antemortem and post-mortem inspection under veterinary supervision in an official approved slaughterhouse and found fit for human consumption; the meat/meat products and/or the packaging thereof bears an official mark (e) indicating that they have been obtained, processed, packaged, labelled and stored in officially approved establishments in accordance with relevant food hygiene regulations and are fit for human consumption;
