#### AB summary of discussion regarding the 19 projects above:

Nineteen applications were received between June 2022 and September 2024 from schools seeking to join Embark Multi Academy Trust. All schools are situated within the Derbyshire Local Authority area. The trust has developed a membership model, which is currently only available to schools with applications to join the trust.

To manage the large pipeline of schools wishing to join Embark Multi Academy Trust, schools were prioritised on the basis of a range of factors including the capacity of the trust and its current hub structure, the position and needs of the schools, and the strategic needs of the area.

The 6 schools prioritised for the next phase of growth are rated good or outstanding in all areas in their latest Ofsted inspections and should add improvement capacity to the trust. They are located in the High Peak and Amber Valley.

There are currently only a small number of academies in Buxton and High Peak. This includes Buxton Community School, which is a secondary school, already part of Embark Multi Academy Trust. Five of the 6 schools in this next group of prioritised schools are part of an existing partnership and ultimately feed into Buxton Community School.

The sixth school approved, Ripley Junior School, has an existing relationship with the trust having worked with Embark Multi Academy Trust since 2022. The school would join the Amber Valley hub, which is the most established hub in the trust (growing to 9 schools).

To ensure a manageable rate of growth of the trust, 13 applications are declined at this time. Future applications to join Embark Multi Academy Trust will be considered by the department after a period of consolidation of at least 12 months using the High-Quality Trust Framework.

Regions Group East Midlands will offer each of the schools with a declined application the opportunity for a conversation about next steps for the school.

The supportive deployment of a school resource management adviser was also recommended.

## Derby

#### **Converter academy orders**

**Caveat:** The following 3 projects were discussed as one proposal. The Advisory Board discussion summary follows at the end.

Project: An application from Bridge Street School, Derby, to convert and become an academy and set up a new trust called RESPECT Collaboration Trust.

Project: An application from Castle School, Derby, to convert and become an academy and set up a new trust called RESPECT Collaboration Trust.

#### Project: An application from Kingsmead School, Derby, to convert and become an academy and set up a new trust called RESPECT Collaboration Trust.

#### AB discussion:

Bridge Street School, Castle School, and Kingsmead School are seeking to voluntarily convert to academy status and establish RESPECT Collaboration Trust. The trust will consist of one special school and two pupil referral units, all dedicated to supporting pupils with social, emotional, and mental health (SEMH) needs.

- Bridge Street School (ages 5 to 16, 150 places) is a pupil referral unit. The school was last inspected by Ofsted in December 2024 and was rated *Good* across all subjudgements.
- Castle School (ages 5 to 18, 100 places) is a pupil referral unit. The school was last inspected by Ofsted in March 2023 and was judged to *continue to be good*.
- Kingsmead School (ages 10 to 18, 180 places) supports students where SEMH is the primary area of need. The school was last inspected by Ofsted in September 2023 and was judged to *continue to be good*.

RESPECT Collaboration of Schools is a well-established organisation with a strong track record of supporting students with SEMH needs across Derby Local Authority. The trust aims to create an inclusive education network where all students receive equitable, high-quality support. Academy status will provide RESPECT with greater flexibility in decision-making, allowing it to respond quickly to the evolving needs of students in Derby and beyond.

This proposal aligns with the department's strategic priorities for the area, which highlight the need to grow trusts that support pupil inclusion, increase attendance, reduce preventable exclusions, and improve outcomes for vulnerable children and those with special educational needs and disabilities (SEND). The applications were assessed using the High-Quality Trust Framework, considering both quantitative and qualitative evidence in relation to the strategic needs of the schools.

**Further actions required:** Feedback decision to the schools/trust and Derby Local Authority. The supportive deployment of a school resource management advisor was recommended.

## Nottinghamshire

#### **Converter academy orders**

# Project: An application from Newark Orchard School, Nottinghamshire, to convert and become an academy and join Community Inclusive Trust.

#### AB discussion:

Newark Orchard School seeks to voluntarily convert to academy status and join Community Inclusive Trust. A resolution has been passed by the school's governing body. The school was last inspected (short inspection) by Ofsted in November 2024 and judged as continues to be good.

Newark Orchard School is an all-through special school for pupils aged 3 to 18 with moderate, severe and profound learning difficulties, multi-sensory impairment and challenging behaviour associated with learning difficulties. All pupils attending the school have an education, health and care plan.

Nottinghamshire local authority commissioned Community Inclusive Trust to support the school in 2023/24, due to the school requesting additional support from a trust that had the capacity to share resources.

Since receiving support from Community Inclusive Trust, Newark Orchard School has made significant improvements, culminating to a good continues to be good Ofsted short inspection in November 2024.

Community Inclusive Trust and Newark Orchard School feel their visions align very closely...

Newark Orchard School joining the trust would be mutually beneficial as the school will continue to benefit from the trust's educational expertise and economies of scale. The trust also reports that the school would add capacity to the trust as a good special school.

The quantitative and qualitive evidence relating to the trust as outlined in the High-Quality Trust Framework was considered against the school's strategic needs.

Decision: Approve.

**Conflicts:** Ash Rahman. Ash is the CEO of Nova Education Trust. A Trustee at Nova Education Trust is also an employee at Community Inclusive Trust
