The 'Maintain Local Land Charges' service has been upgraded

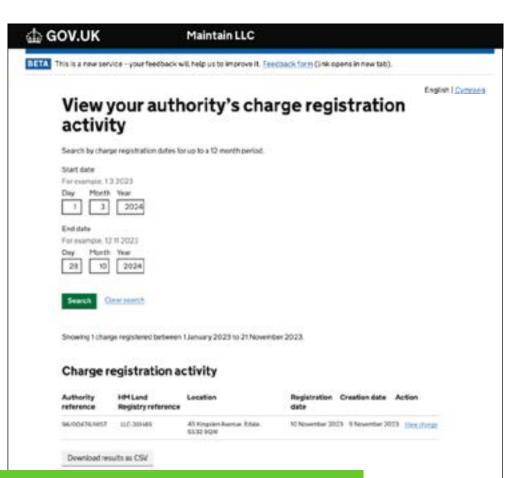
On 28 January 2025, we launched a new feature in the Maintain Local Land Charges (LLC) service. The 'View your authority's registration activity' tool allows you to track LLC registration activity simply. With quicker access to a list of your registrations, you now have complete visibility of all the charges registered by, or on behalf of, your authority since you migrated.

How it works:

- log into the <u>Maintain Local Land</u> <u>Charges service</u>
- in the 'Manage charges' section on the homepage, select 'View your authority's registration activity'.
- If you've forgotten your password, you can easily reset it. You can

contact your Relationship Manager if you need help with the reset.

 To search, enter a date range when the charges were registered. You can search across any timeframe that does not exceed 12 months. The search dates can be altered on the results screen.





 To view the details of a particular charge, simply select 'View charge'. The full list of results can also be downloaded as a .csv file for review and analysis.

Planned developments

In the coming months, we will introduce a suite of developments that will significantly improve your experience of this service. The next phase will focus on improving 'Add a charge', followed by enhancements to 'Find, update, or cancel a charge'.

Is your data 'gold standard'?

We want to help local authorities (LAs) better understand their data, so we can introduce improvements that create efficiencies and cost savings. By the end of February, we will have informed each LA how we have classified their data – whether it's bronze, silver, or gold.

Our Service Performance and Integration (SPI) team will support each LA to improve their data classification, so that all data eventually becomes gold standard. We want every authority to be able to maximise their data usage and enable customers to get the service they deserve. On 11 March 2025, we will celebrate the 2025 Land Data Awards and announce the winner of the Best Performing Migrated LA, virtually, for the first time. The award celebrates the LA's outstanding management of the register and for maintaining good communication with us, which is helping property buyers achieve the best outcomes.

In January we published the details of the 76 LAs who have achieved gold standard on <u>GOV.UK</u>, to publicly recognise their efforts. The Land Data Best Performing Migrated LA award winner will be selected from one of these LAs.

Land Data will not only hold the award ceremony virtually, but also the Local Land Charges Training & Development Event. Delegates can expect the twoday event on 11-12 March 2025 to provide:

 learning and debates focused on topics suggested by former delegates

- presentations from speakers across local and central government, professional bodies, and industry
- opportunities to ask questions and take part in the annual quiz
- the announcement of the Best Performing Migrated LA.

Whether you win or make the shortlist, being recognised puts a spotlight on the great work your LLC team does for your LA and customers.

Local authority and other originating authorities survey results

We would like to thank everyone who took the time to complete our local authority (LA) and other originating authority (OOA) survey. The results are currently being reviewed and analysed by the Service Performance and Integration (SPI) team. When all the responses have been evaluated, we will create an action plan of improvements that will be introduced over the coming months.

The insight from the survey is helping us to better understand how stakeholders feel about the service and the support we provide post-migration. The areas the survey focused on include:

- The handover from migration into live service
- Whether the quality and performance packs are useful
- The day-to-day life of LAs and understanding if further support is required

We received many comments about the migration to live service handover pack; so it will be refined to improve its clarity and usefulness. More information about this and the action plan will be shared shortly.

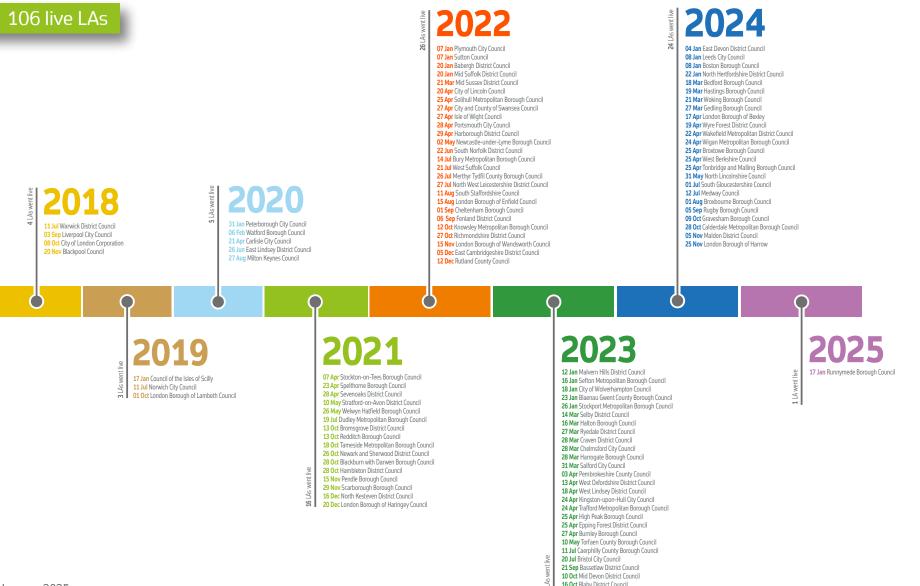
Read our latest case study

The national LLC Register cost savings

Since programme launch, the LLC Register has recorded a total cost saving of over £2.7million from searches with customers in migrated areas, saving an average of 12.6 days to obtain an LLC search result. More than 6.3 million charges from 106 local authorities have been migrated to the register.
