



# Woodland improvement pre-application form

Only complete this form if you've been invited to submit a pre-application form for woodland management actions under Countryside Stewardship Higher Tier (CSHT).

You must have a current Woodland Management Plan (WMP) approved by the Forestry Commission to apply. Your WMP must be in place for the 10-year length of your agreement.

If your WMP is due to expire during your agreement, you must have a new one in place before it ends. The Forestry Commission recommends you apply the year before it ends.

## **Section 4: species management**

You must have a species management plan (approved by the Forestry Commission or Natural England) if you want to apply for supplements or items that fund the management of:

- deer
- squirrel
- invasive plant species
- edible dormouse
- mink

You will need a plan for each species you want to manage.

You may be able to <u>apply for PA7: Species management plan</u> to help pay for this. If you apply for PA7, do not start writing your plan until it is approved.
