#### INTRODUCTION

- 1. I am directed by the Secretary of State to draw your attention to the revision of the following documents to correct minor errors:

#### APPLICATION OF THE APPROVED DOCUMENTS

4. The changes made to the Approved Documents only apply to buildings and building work in England.

#### TRANSITIONAL ARRANGEMENTS

5. The revisions to the guidance come into force on 2 March 2025. They do not affect the timelines set out in <u>Approved Document B (Fire Safety)</u>: new updates to support enhanced fire safety - GOV.UK published on 02 September 2024.
