## **Agenda item 1: Introduction**

1.1 The chair reminded the meeting of the confidentiality of the papers and their discussions. If members believed that they had a commercial or financial interest in any of the items being discussed, they were required to declare their interest to the chair and secretariat prior to the meeting. # Agenda item 3: Matters arising and forward business plan [ECP 2 (69/2025)]

- 3.1 The secretariat provided an update on matters arising from previous meetings and invited members to suggest any additions or amendments to the forward business plan which would be incorporated before the next meeting.
- 3.2 Members discussed the outstanding residue section of the dimpropyridaz active substance dossier. HSE confirmed they are still in discussions with the applicant over further data and will liaise with the secretariat to agree a date for HSE to present the data to the relevant members for advice.

# Agenda item 4: Independent scientific advice: Dimpropyridaz [ECP 4 (69/2025)]

- 4.1 Dimpropyridaz was first considered by the committee in November 2023. HSE identified several areas that would require advice, and the committee members could explore any aspects of the risk assessment and underlying guidance they considered to be of interest.
- 4.2 The secretariat introduced a working draft of the independent scientific advice for dimpropyridaz. Members formally approved the draft note as a true representation of the advice they provided, with the limitation that the advice note will not be submitted to HSE until the committee has considered and advised on the outstanding residue risk assessment section.

# Agenda item 5: Draft 2024 ECP annual report [ECP 4 (698/2025)]

- 5.1 The secretariat introduced the first draft of the 2024 ECP annual report. The report details the work undertaken by the committee, alongside reporting on the fees and expenditures of the committee and the declaration of interests provided by members.
