
About this booklet



We have another booklet called **Changes we want to make to the law about pay**.

How we look after your information









Your **personal information** is anything that tells other people who you are, like your name or email address.

We will follow the law in the UK to look after your personal information.



On pages 4 to 7 we tell you how we will look after your personal information. It's called our **privacy notice**.

Privacy Notice

A **privacy notice** is a document that says how we look after your information.



We need your personal information to find out what you think about a topic that's important for lots of people.

We will ask for information about you or your organisation

- to help us find out which groups of people give us information, and which do not.
- to help us contact you if you need information in another format like Audio or Braille.



We will ask

- your name.
- your address.
- your email address.
- your phone number.
- your organisation name and the country where they work.
- information about you like your ethnicity, disability, age and sex.
- what you think.



We will keep your personal information. We will also share it with the company we have chosen to help us with this survey.



We might **back up** your information outside the UK. We will follow the law to keep your information safe.



Back up means we keep a copy so it cannot be lost.



We will keep

- your personal information while this survey is happening, if you need information in another format.
- your answers about what you think for 3 years.





You can ask us

- more about what we do with your information.
- to change your information if it's wrong.
- to delete your information if we do not need it anymore.
- to stop using your personal information.









How to tell us about pay gaps because of ethnicity


How to tell us about pay gaps because of disabilities
