## Russian Additional Duties Document

14 March 2025

Version 1.5

## Overview

This document is the Russian Additional Duties Document, version 1.5, dated 14 March 2025, which is given effect by the Customs (Additional Duty) (Russia and Belarus) Regulations 2022, amended by the Customs (Tariff and Miscellaneous Amendments) Regulations 2022.

The product descriptions that are contained in Column 2 of the Tables are provided for information purposes only. In the product descriptions the abbreviation n.e.s. means 'not elsewhere specified'. Any questions regarding the scope of particular commodity codes should be referred to HMRC at [classification.enquiries@hmrc.gov.uk](mailto:classification.enquiries@hmrc.gov.uk).
