- 31 October 2025 if you want us to calculate the tax
- · 31 January 2026 at the latest

If we do not receive the tax return by 31 January 2026, an automatic penalty of £100 will be charged. Make sure payment of any tax that the company or other entity owes reaches us by 31 January 2026, or the company or other entity will have to pay interest and possibly a late payment penalty. We may check any tax return. There are penalties for supplying false information.
