Agenda item 1: welcome, announcements, etc.

The chair welcomed all those attending, in person and by video conference. He welcomed in particular Sarah Bergstrom and Sarah Hannah of the Criminal Appeal Office, attending for the discussion of item 10, and other guests.

He reported apologies for absence from Mrs Justice Foster, Shade Abiodun, Chief Constable Rob Nixon QPM and Robert Thomas.

Agenda item 2: draft minutes of the meeting on 13th December, 2024

The draft minutes were adopted, subject to any correction to be notified by members to the secretary.

Agenda item 3: case management group report

The chair reported that the group had:

- 1) reviewed the form of application for a special measures direction and settled adjustments to encourage an applicant for special measures to consider provision for a young witness who was likely to reach the age of 18 before beginning to give evidence.
- 2) settled a form of application for an order under section 7, Bankers' Books Evidence Act 1879 and CrimPR 17.3, and amendments to current forms of application for a witness summons.
- 3) discussed potential amendments to Criminal Practice Directions concerned with jury irregularity and corrected a reference to judicial guidance on dealing with contempt of court.
- 4) reviewed and elaborated a draft form of preparation for effective trial of the alleged breach of a community-based order or post sentence supervision.

Agenda item 4 (paper (25)01): Committee programme for 2025

The Committee:

- 1) briefly reviewed work completed during 2024;
- 2) noted suggestions for future work and agreed to send to the secretary such further suggestions as might arise; and
- 3) discussed, among other subjects, the potential for encouraging a more sympathetic and satisfactory treatment of the victims of crime.

Agenda item 5 (paper (25)02): survey of intermediaries' experiences

The Committee:

- 1) held a preliminary discussion of the survey; and
- 2) postponed further discussion to the next meeting at which a representative of Intermediaries for Justice could attend.

Agenda item 6 (papers (25)03 & (23)09): application for transcript, revision of CrimPR 5.5

The Committee approved in principle the proposed revision of the rule but subject to:

- 1) alignment of references to reporting restrictions in rule 5.5 with corresponding references in rule 5.8; and
- 2) inclusion of reference to the court's power in some circumstances to direct the provision of transcript at public expense.

Agenda item 7 (paper (25)04): taking depositions under Schedule 3, Crime and Disorder Act 1998

The Committee:

- 1) held a preliminary discussion of the proposal;
- 2) agreed that the procedure was rarely used but remained worth providing for; and
- 3) directed the preparation of draft rules.

Agenda item 8 (papers (25)05 & (24)70): animals to support vulnerable people

The Committee:

- 1) agreed that such provision might be directed, exceptionally;
- 2) directed substantial abbreviation of the suggested Criminal Practice Directions; and
- 3) directed the removal of detailed provision to a draft form of application for such a direction, for discussion by the Committee's case management group.

Agenda item 9 (paper (25)06): disclosure and declarations by expert witnesses

The Committee:

- 1) approved in principle the suggested amendments to Criminal Practice Directions; but
- 2) directed consultation with the Forensic Science Regulator and with the expert witnesses directly affected by the matters in issue before further discussion.

Agenda item 10 (papers (25)07 & 08): service of notice of appeal under CrimPR Part 42 and associated rule amendments

The Committee approved the proposed rule amendments.

Agenda item 11 (paper (25)09): index to the Criminal Procedure Rules, further progress report

The Committee:

- 1) thanked Mr Barrand for achieving this objective;
- 2) directed publication of the index on the government's Criminal Procedure Rules web pages; and
- 3) identified individual members who would assist in securing its publication in relevant textbooks.

Agenda item 12 (paper (25)10): guidance for unrepresented defendants, further progress report

The Committee:

- 1) thanked Mr Barrand and Professor Thomas KC for their continuing work on this objective;
- 2) acknowledged other relevant work recently begun by HM Courts and Tribunals Service; and
- 3) discussed the means by which the guidance would be made available, where, by whom, and at what stage of proceedings.
