# Cambridgeshire

### **Trust changes**

Project: An application for Soham Village College [URN: 136610], Kennett Primary School [URN: 139088], The Shade Primary School [URN: 139555] and The Weatheralls Primary School [URN: 143941], Cambridgeshire to transfer from Staploe Education Trust to Anglian Learning.

#### Representations received:

No representations were made for this project.

#### **AB Discussion:**

- The board heard about the voluntary application to close Staploe Education Trust and transfer all its academies to Anglian Learning.
- The board heard about the shared ethos and values between both trusts and their existing professional working relationship.
- The board heard that Anglian has increased its central team capacity by appointing Directors of Primary and Secondary and increased SEND capacity to improve its overall school improvement offer.
- The board heard Anglian is currently onboarding two academies into the trust. If the Staploe transfer is approved, Anglian would increase in size from 16 to 22 academies in under a year. If the project is approved, Anglian would not look to onboard any further academies until the existing ones were embedded.
- The board heard about the financial position of Staploe and that Anglian will complete further due diligence checks and financial modelling to manage the financial risk.
- The board discussed the finances, capacity and timing of the expansion. The
  Regional Director asked his team to secure some further information on Anglian
  Learning Trust's plans for enhancing its capacity in line with this level of growth. This
  information has been secured, and the Regional Director gave his approval to the
  proposal.
