BUSINESS APPOINTMENT APPLICATION: Rt Hon Dame Amanda Milling DBE, former Government Whip for HM Treasury in the House of Commons. Paid appointment with Johnson and Lubbock Partners Limited.

- You sought advice from the Advisory Committee on Business Appointments (the Committee) under the government's Business Appointment Rules for Former Ministers (the Rules) on taking up an appointment with Johnson and Lubbock Partners Limited (JL Partners) as a Consultant.
- 2. The purpose of the Rules is to protect the integrity of the government. The Committee has considered the risks associated with the actions and decisions made during your time in office, alongside the information and influence a former Government Whip for HM Treasury in the House of Commons may offer JL Partners. The material information taken into consideration by the Committee is set out in the annex.
- 3. The Committee's advice is not an endorsement of the appointment it imposes a number of conditions to mitigate the potential risks to the government associated with the appointment under the Rules.
- 4. The Ministerial Code sets out that ministers must abide by the Committee's advice. It is an applicant's personal responsibility to manage the propriety of any appointment. Former ministers of the Crown, and Members of Parliament, are expected to uphold the highest standards of propriety and act in accordance with the 7 Principles of Public Life.

The Committee's consideration of the risks present

- 5. You did not meet with JL Partners during your time as a minister, nor did you make any decisions specific to the company whilst in office. Therefore, the Committee¹ considered the risk this appointment could reasonably be perceived as a reward for decisions made or actions taken in office is low.
- 6. As a former minister who was responsible for discussing and moving the government's legislative programme in the House of Commons, there are inherent risks associated with your access to privileged information, contacts and influence within government. The risks are limited as Cabinet Office is not aware of any information that would offer JL Partners an unfair advantage and it has been seven months since you left office.
- 7. The Committee considered there are risks associated with the unknown nature of JL Partners clients, should you be asked to advise on matters you had involvement in whilst in government; or were you to advise clients you had contact with while in office. The Committee recognised that as you were not generally materially involved in policy development, this risk is limited.
- 8. As a former minister there are inherent risks with your network and contacts in government. As there is a business development aspect to this role, there is also a possibility you might draw on external contacts gained whilst in office. However, it is significant you previously worked in market research prior to joining government, nor were you in an externally facing role in your most recent role in office.

The Committee's advice

- 9. The Committee determined that the risks identified in this application can be appropriately mitigated by the conditions below. These make it clear that you cannot make use of your access to privileged information, contacts or influence gained from your time in ministerial office to the unfair advantage of JL Partners or its clients.
- 10. To address the unknown risks associated with JL Partners' clients, the Committee has imposed a condition to limit the potential for conflict, albeit the risk is limited you must not advise on matters you had a material role in whilst in office, should that situation arise.
- 11. Taking these factors into account, in accordance with the government's Business Appointment Rules, the Committee's advice is this appointment with

Johnson and Lubbock Partners Ltd be subject to the following conditions:

- you should not draw on (disclose or use for the benefit of yourself or the persons or organisations to which this advice refers) any privileged information available to you from your time in ministerial office;
- for two years from your last day in ministerial office, you should not become personally involved in lobbying the UK government or its arm's length bodies on behalf of Johnson and Lubbock Partners Ltd (including parent companies, subsidiaries, partners and clients); nor should you make use, directly or indirectly, of your contacts in the government and/or ministerial office to influence policy, secure business/funding or otherwise unfairly advantage Johnson and Lubbock Partners Ltd (including parent companies, subsidiaries, partners and clients);
- for two years from your last day in ministerial office you should not undertake any work with Johnson and Lubbock Partners Ltd (including parent companies, subsidiaries, partners and clients) that involves providing advice on the terms of, or with regard to the subject matter of a bid with, or contract relating directly to the work of, the UK government or its arm's length bodies; and
- for two years from your last day in Crown service, you must not advise JL Partners or its clients on any work with regard to any policy which you had a material role in developing or determining as Government Whip for HM Treasury in the House of Commons, or where you had a relationship with the company or organisation during your time in this role.
- 12. The advice and the conditions under the government's Business Appointment Rules relate to your previous role in government only; they are separate from rules administered by other bodies such as the Office of the Registrar of Consultant Lobbyists, the Parliamentary Commissioner for Standards and the Registrar of Lords' Interests². It is an applicant's personal responsibility to understand any other rules and regulations they may be subject to in parallel with this Committee's advice.
- 13. By '*privileged information*' we mean official information to which a Minister or Crown servant has had access as a consequence of his or her office or employment and which has not been made publicly available. Applicants are also reminded that they may be subject to other duties of confidentiality, whether under the Official Secrets Act, the Civil Service Code or otherwise.

- 14. The Business Appointment Rules explain that the restriction on lobbying means that the former Crown servant/minister 'should not engage in communication with government (ministers, civil servants, including special advisers, and other relevant officials/public office holders) wherever it takes place with a view to influencing a government decision, policy or contract award/grant in relation to their own interests or the interests of the organisation by which they are employed, or to whom they are contracted or with which they hold office.' This Rule is separate and not a replacement for the Rules in the House.
- 15. You must inform us as soon as you take up this role, or if it is announced that you will do so. You must also inform us if you propose to extend or otherwise change the nature of your role as, depending on the circumstances, it may be necessary for you to make a fresh application.
- 16. Once the appointment has been publicly announced or taken up, we will publish this letter on the Committee's website, and where appropriate, refer to it in the relevant annual report.

Annex - Material Information

The role

- JL Partners is a firm that specialises in research, insight and strategy, particularly in the political sphere. It aims to gain insight into a client's target audience and develop strategies (campaign design, market engagement etc) to meet the client's end goal. Its products include research and polling, among others. The firm was founded by Prime Minister Theresa May's former Senior Opinion Research and Strategy Advisor.
- 2. You said in your paid, part-time capacity as a Consultant your responsibilities will include supporting on:
 - a. Project technical proposals
 - b. Pitches
 - c. Credentials
 - d. Business Development
- 3. You stated that in your role you will not have any contact with government.

Dealings in office

4. You advised the Committee that you did not meet with JL Partners whilst in office. You said you did not have any involvement in policy, regulatory or commercial decisions that would have been specific to the company.

Departmental Assessment

5. The Cabinet Office confirmed the details you provided and recommended the standard conditions.
