- (3) Horses, including their external genitalia, must be thoroughly examined. Horses may require tranquilization or sedation for the examination.
- (4) The examination of the horse needs to be performed by either a full time salaried veterinary official of DEFRA/DAERA or a veterinarian acting on behalf of DEFRA/DAERA (OV)
