Environmental Information Regulations – Information Request

Thank you for your email on 09 January, in response to our email of the same day regarding your request for information with the reference RFI 7255. Your request has been dealt with under the Environmental Information Regulations 2004 (EIR).

You have requested the following information:

- How many calves, less than one month old, were killed in UK abattoirs in 2024?
- Of these calves, how many were aged 7-10 days old?
- How many female cattle aged over 1 years old were slaughtered in UK abattoirs in 2024?
- Of these cows, how many were older than five years old?

The Rural Payments Agency (RPA) can confirm that between 1 January and 31 December 2024.

- A total of 36,517 calves, less than one month old, were killed in GB Abattoirs.
- Of these, 3,547 were aged between 7-10 days old.
- A total of 1,250,536 Female Cattle, aged 1 year and over, were killed in GB Abattoirs.
- Of these, 364,646 were aged 5 years and over.

The figures provided are correct as of 15 January 2025.

Please be advised, the information provided relates to GB abattoirs as the RPA does not hold the information relating to Northern Ireland. Therefore, this information is not held.

The information you have requested is therefore exempt from disclosure under regulation 12(4)(a) EIR 'Information not held'. This is a qualified exemption, which usually means that a public authority is required to conduct a public interest test to determine whether or not information should be disclosed or withheld. However, the Information Commissioner (IC) takes the view that a public interest test in cases where

the information is not held would serve no useful purpose. Therefore, in line with the IC's view RPA has not conducted a public interest test in this case.

Regulation 9 of EIR requires public authorities to provide advice and assistance to applicants where reasonable.

If you require the data for Northern Ireland, you will need to request information from them by email at <u>daera.informationmanager@daera-ni.gov.uk</u>

We also attach Annex A below, explaining the copyright that applies to the information being released to you.

What you need to do

If you are not happy with the way we have handled your request, you can ask for an internal review. These requests should be submitted in writing within two months of the date of receipt of the response to your original request. You should email your request for a review to <u>IRT@rpa.gov.uk</u>

If you are not content with the outcome of the internal review, you have the right to apply directly to the Information Commissioner for a decision by following the link to the Information Commissioner's website <u>here</u>.
