Advice and Assistance

We have a duty to provide advice and assistance in accordance with Section 16 of the FOIA. To comply with this duty we are able to confirm that the investment functions of the Housing Corporation transferred into Homes England at the inception of the Homes & Communities Agency (HCA) in 2008. The Regulatory functions went firstly to the then newly created Tenant Services Authority, which was also subsequently transferred into the Homes & Communities Agency in March 2012. In October 2018, a new agency called the Regulator of Social Housing (RSH) was established and both functions were then passed back to that Agency, including all original records from the Housing Corporation. The physical records that the Corporation had at archive were very small and these went with RSH when they split off from HCA.
