## **Converter academy orders**

Points discussed in relation to school conversion.

Project: An application from The Lampard Community School (URN113637), Devon to convert and become an academy and join Special Partnership Trust.

Project: An application from Horfield Church of England Primary School (URN 109143), Bristol, City of to convert and become an academy and join Lighthouse Schools Partnership.

Project: An application from Paxcroft Primary School (URN 126483), Wiltshire to convert and become an academy and join Equa Mead Learning Trust.

**Representations received:** \*\* all projects for Equa Mead Learning Trust were discussed together.

#### **AB Discussion:**

- All three schools have applied to voluntarily convert to academy status and join Equa Mead Learning Trust (EMLT).
- Urchfont Church of England Primary School is a 4-11 voluntary controlled primary school and received a Good Ofsted judgement in May 2023.
- Five Lanes CofE VC Primary School is a 4-11 voluntary controlled primary school and received a second Requires Improvement Ofsted judgement in June 2024.
- Paxcroft Primary School is a 4-11 foundation primary school and received a Good Ofsted judgement in March 2024.
- The schools' leaders consider that by joining EMLT, there will be enhanced opportunities and resources for their children. Additionally, leaders say that all children and young people will benefit from a more diverse curriculum, and a vision and values that align with their own.
- The governance and structure of the board was discussed. The trust has 12 trustees and 7 members. The trust plans to have up to 8 members and they recognise this is a larger number than most trusts. On approval of the merger of Equa and Mead in February 2024, the Regional Director recommended an external review of governance, and this is due within the next 6 months.

Project: An application from Charter Primary School (URN 126292), Wiltshire to convert and become an academy and join The AthelstanTrust.

When received in time, representations are shared in advance of the meeting with all attendees, who considered them alongside the corresponding item.

#### Points raised in Discussion:

- All three schools have applied to voluntarily convert to academy status and join The Athelstan Trust.
- Abbeyfield School received a Good Ofsted judgement in November 2022.
- Kings Lodge Primary received a Good Ofsted judgement in November 2021.
- Charter Primary received a Requires Improvement Ofsted judgement in July 2024.
- The schools are beginning to work together and have a history of collaboration.
- The financial position of Abbeyfield was discussed. Abbeyfield's financial position is improving. The Schools Financial Support and Oversight directorate (SFSO) will continue ongoing monitoring and on approval would require quarterly updates.
   Regions Group with the SFSO will discuss this with the trust.
- It was recommended that as the trust grows, the trust considers a review of its school improvement model and how to develop the model in line with trust growth.
- The diversity of the trust board and the educational expertise across primary was discussed. Regions Group will discuss the trust's plans to address this issue and will recommend partnering with a primary trust with a strong track record of improving outcomes.
- It is recommended that the incoming Athelstan CEO has a mentor to provide positive and constructive support as the trust grows, and to take part in the DfE 'Working with Regions Group' programme. Regions Group will discuss this with the trust and CEO and provide suggestions.

## **RD decision:** Approve with conditions

- The Athelstan Trust to partner with a trust that has strong primary expertise and led by an experienced MAT CEO to carry out a review of the trust's school improvement strategy and effectiveness. (Regions Group to suggest suitable trusts for this role).
- Quarterly financial monitoring of the trust and the management of Abbeyfield School's deficit by SFSO.

Representations received: \*\* all projects for The Leaf Trust were discussed together.

No representations were made for this project.

- All three schools have applied to voluntarily convert to academy status and join The Leaf Trust.
- Crossways Infant and Junior Schools (federated) share The Leaf Trust's vision and values and will benefit from unified support while keeping their unique identities.
- Crossways Infant School received a 'Requires Improvement' judgement from Ofsted in October 2023, while Crossways Junior School received a 'Good' judgement in June 2024.
- Sea Mills Primary School will gain from experienced leaders, collaboration, and professional development, while keeping its strong local community and unique identity with The Leaf Trust's support. The school received a 'Good' judgement from Ofsted in June 2023
- All three schools are already working with The Leaf Trust. Leaf has supported leadership at the Crossways schools and provided leadership support and improvement planning at Sea Mills.
- The Leaf Trust was established in September 2023 and as a new trust does not have a proven track record of performance. However, Regions Group recognised the experienced leadership in the trust.
- The growth strategy of the trust was discussed with a period of consolidation recommended. Regions Group will continue to discuss growth plans with the trust and will continue to make future growth decisions based on the High-Quality Trust Framework.

Project: An application from St John's Catholic Primary School (URN 109260), Bath and North East Somerset to convert and become an academy and join The Dunstan Catholic Educational Trust.

**Representations received:** \*\* all projects for The Dunstan Catholic Academy Trust were discussed together.

• No representations were made for this project.

- All three schools have applied to voluntarily convert to academy status and join The Dunstan Catholic Educational Trust (DCET).
- St Mary's Catholic Primary School received a Good Ofsted judgement in October 2018 and has consistently maintained Good or Outstanding judgements since opening.

- St Benedict's Catholic Primary School received a Requires Improvement Ofsted judgement in May 2023.
- St John's Catholic Primary School received a Good Ofsted judgement in September 2023.
- The schools believe that conversion offers key benefits: preserving the Catholic vision and ethos, enhancing opportunities for teachers to share knowledge, achieving cost savings through bulk purchasing, providing new leadership and career opportunities, promoting job security for staff, and reducing duplication of work for leaders.
- Established in 2022, DCET is a ten-school Catholic trust with a presence in Somerset, North Somerset, BANES and Wiltshire.
- The proposal for these schools to convert and join DCET is aligned with the Bishop's vision and strategic plan.
- The growth strategy of the trust was discussed with a period of consolidation recommended. Regions Group will continue to discuss growth plans with the trust and will continue to make future growth decisions based on the High-Quality Trust Framework.
- The diversity of the trust board was discussed and the benefits of an external review of governance and the addition of individuals with specific skills and the appropriate level of support and strength to challenge. This will be raised with the trust by Regions Group.
- It is recommended for the chair to have a mentor to provide positive and constructive support as the trust grows. Regions Group will provide suggestions.

**RD decision:** Approve with conditions

 The Dunstan Catholic Educational Trust should commission a review of their School Improvement Strategy and structures from a trust that has strong expertise in this area. The outcomes of this review should be shared with Regions Group ahead of any decisions about future growth. (Suitable trusts for this role to be suggested by and agreed with Regions Group).

## Significant changes to an open academy

Points discussed in relation to significant changes to an open academy

Project: An application for St Martin's Garden Primary School (URN 16156), Bath and North East Somerset (Palladian Academy Trust) to make the following change:

To expand the existing resource base, increasing capacity from 34 to 60 places.

Project: An application for An application for Ralph Allen School (URN 138522), Bath and North East Somerset (Palladian Academy Trust) to make the following change:

• To establish a 20-place resource base for pupils with ASD (Autism Spectrum Disorder) and complex needs.

**Representations received:** \*\* all projects for The Palladian Academy Trust were discussed together.

No representations were made for this project.

#### Points raised in Discussion:

- The Margaret Coates Centre (MCC) at St Martins Gardens (SMG) supports pupils with ASD and complex needs.
- The proposal seeks to increase MCC's capacity from 34 to 60 places by repurposing two unused classrooms within SMG, requiring minimal refurbishment funded by the local authority - Bath and North East Somerset Council.
- Creating a New Resource Base at Ralph Allen School (RAS). The plan includes building a single-storey rooftop extension on the Design and Technology (DT) block to set up a SEND Resource Base (RB) for up to 20 pupils, with a focus on ASD support.
- There is a growing need for specialist ASD provision in BANES. Expanding the MCC at SMG will increase capacity for high-needs pupils, while the new resource base at RAS will enhance inclusion and support the transition from the primary to the secondary phase.
- The financial position of SMG was discussed and financial pressures for the trust. This is being managed through ongoing monitoring by the SFSO Directorate.
- Regions Group will continue to collaborate closely with the trust, holding regular strategic conversations to review progress.
- AB members discussed the recruitment of a permanent headteacher at SMG. It is important that the new headteacher can manage the expanded needs of the resource base. Regions Group are in discussion with the trust to ensure that support is in place.

Project: An application for Horizons Therapeutic Education Trust (SAT) (URN 150859), Somerset (Horizons Therapeutic Education Trust) to make the following change:

 To open a satellite site in Wellington to provide therapeutic education for 15 pupils with complex needs.

**Representations received:** No representations were made for this project.

- Horizons Therapeutic Education Trust (HTET) is a single academy trust (SAT)
  alternative provision (AP) free school in Somerset. Opened in September 2024, it is
  designed to provide therapeutic education for young people with complex needs.
- This project has a multi-agency approach led by Somerset LA, Shaw Trust and NHS Somerset Foundation.
- This proposal will enhance curriculum provision, addressing the priority needs for specialist education in Somerset for children with complex needs.
- AB Members asked about the assessment of learning outcomes. This will be

- discussed with the trust and Regions Group as they move into this new phase.
- The trust plans to appoint an external advisor to help with curriculum development, reintegration pathways, and student progress tracking.
- On approval of the opening of Horizons in September 2024 a condition was put in place that required appointment of a 5<sup>th</sup> member and Regions Group will request an update from the trust on progress.
- The current provision is operating effectively, and outcomes are positive. Regular meetings between the trust and Regions Group are held to monitor its development and delivery, with financial oversight provided by the ESFA.
- The AB members recommended implementing a quality assurance framework, which the trust is already actively exploring for implementation.

Project: An application for Moat Primary Academy (URN 144472) and Robinswood Primary Academy (URN 136528), Gloucestershire (Greenshaw Learning Trust) to make the following change:

• To merge Moat Primary Academy with Robinswood Primary Academy, and form one entity on the site of Robinswood Primary Academy.

#### Representations received:

Eight representations were received for this project.

When received in time, representations are shared in advance of the meeting with all attendees, who considered them alongside the corresponding item.

- Greenshaw Learning Trust (GLT) is seeking approval to merge two nearby schools, Moat Primary Academy and Robinswood Primary Academy, and to extend the age range at Robinswood to reflect the current 2-4 age range at Moat nursery.
- Moat Primary Academy is situated in the Matson area in the south of Gloucester City. The school joined GLT in November 2023. Moat currently has 127 pupils against a 234 capacity. The site at Moat is in a poor state of repair and is in scope for a full rebuild under the School Rebuilding Programme (SRP).
- Robinswood Primary Academy is also situated in the Matson area of Gloucester. The school joined GLT in November 2023. Robinswood currently has 375 pupils, against a 480 capacity.
- With falling pupil numbers in the area, the trust has concerns that the Moat pupils are
  not able to access as broad and balanced curriculum as they would like to offer. GLT
  are confident that one, larger school in Matson would enhance educational provision,
  as it would be better resourced and structured.
- All representations received were discussed with AB members and the key points were outlined, particularly from the parent community, in regard to the consultation process and practicalities of the proposal. Representations about the change from

- the local MP and councillor were also noted. Assurances were provided by Regions Group that the points raised will be addressed with the trust.
- The Trust's communication and consultation approach with the community was
  discussed. AB members emphasised the necessity for enhanced and ongoing
  communication with the community, and that the Trust must now carefully work with
  parents, staff, pupils and the LA in the lead-up to the merger and provide
  reassurances to all stakeholders involved. Regions Group will work closely with
  Greenshaw Learning Trust in this regard.
