The future of Grenfell Tower

The Deputy Prime Minister recognises that decisions about Grenfell Tower are a deeply personal matter for the people affected.

In February, she met bereaved families, survivors and residents in the immediate community to share her decision that the Tower will be carefully taken down. She has reached this decision after listening carefully to the community and considering independent expert advice.

The government is committed to taking the next steps respectfully and carefully. There will be continued support for, and engagement with, the community throughout the process.

The Deputy Prime Minister will ensure the community continues to have opportunities to speak with her and Ministers on issues that matter to them.

Annual Tower rewrapping

Grenfell Tower is enclosed in two layers of protective wrapping attached to the scaffolding around the Tower. The wrapping protects the building from the weather and prevents any loose material falling into public places. The wrapping also sensitively and respectfully covers the building from view.

The outer layer of wrapping material deteriorates over time, and we need to replace it annually so that it continues to be effective. We'll be replacing the outer wrapping floor by floor. This started in March and we expect it to take about 10 weeks, depending on the weather.

Site works

In preparation for the 8th anniversary of the Grenfell Tower tragedy, an area of the Tower site is being resurfaced. As part of the work, portacabins used by the site contractor, DUK, are being removed by lorry. Lorries will operate during site working hours, 8.30am to 5pm, Monday to Friday. The work will not affect the Tower and DUK will remain working at the site.

DUK carries out regular maintenance and checks of the props (the metal supports installed in the tower), the hoardings around the site, and the lighting, security systems and scaffolding.
