

Anticipated Acquisition by Kpler Holding SA of Spire Global, Inc.'s maritime data business

Initial Enforcement Order made by the Competition and Markets Authority pursuant to section 72(2) of the Enterprise Act 2002 (the Act)

Whereas:

- (a) the Competition and Markets Authority (CMA) has reasonable grounds for suspecting that it is or may be the case that arrangements are in progress or in contemplation which, if carried into effect, will result in Kpler Holding SA (Kpler) and the maritime data business of Spire Global, Inc. (Spire, the acquired business being the Target business) ceasing to be distinct;
- (b) the CMA is considering, pursuant to section 22 or 33 of the Act, whether it is or may be the case that a relevant situation has been created and whether the creation of that situation has resulted or may be expected to result in a substantial lessening of competition in any market or markets in the United Kingdom (UK);
- (c) the Target business comprises the legal entity exactEarth Ltd. (Canada) (CanadaCo), including its subsidiary exactEarth Europe Limited (UK) (UKCo), as well as other assets, such as customer contracts, which are due to transfer from Spire to Kpler as part of the transaction.
- (d) the CMA wishes to ensure that no action is taken pending final determination of any reference under section 22 or 33 of the Act which might prejudice that reference or impede the taking of any action by the CMA under Part 3 of the Act which might be justified by the CMA's decisions on the reference; and
- (e) the circumstances set out in section 72(6) of the Act do not apply and the reference has not been finally determined in accordance with section 79(1) of the Act.

Now for the purposes of preventing pre-emptive action in accordance with section 72(2) of the Act, the CMA makes the following order addressed to Kpler, as well as to CanadaCo and UKCo (Kpler, CanadaCo and UKCo are together referred to as the **Addressees**) (the **Initial Order**).

COMMENCEMENT, APPLICATION AND SCOPE

- 1. This Initial Order commences on the commencement date: being the date of completion of the transaction.
- 2. This Initial Order applies to the Addressees.
- 3. Notwithstanding any other provision of this Initial Order:
 - (a) no act or omission shall constitute a breach of this Initial Order, and nothing in this Initial Order shall oblige the Addressees to reverse any act or omission, in each case to the extent that it occurred or was completed prior to the commencement date;
 - (b) this Initial Order does not prohibit the completion of the transaction provided that the Addressees observe the restrictions set out below.

MANAGEMENT OF KPLER AND TARGET BUSINESSES UNTIL DETERMINATION OF PROCEEDINGS

- 4. Except with the prior written consent of the CMA, the Addressees shall not, during the specified period, take any action which might prejudice a reference of the transaction under section 22 or 33 of the Act or impede the taking of any action under the Act by the CMA which may be justified by the CMA's decisions on such a reference, including any action which might:
 - (a) lead to the integration of the Target business with the Kpler business;
 - (b) transfer the ownership or control of the Kpler business or the Target business or any of their subsidiaries; or
 - (c) otherwise impair the ability of the Target business or the Kpler business to compete independently in any of the markets affected by the transaction.
- 5. Further and without prejudice to the generality of paragraph 4 and subject to paragraph 3, the Addressees shall at all times during the specified period take all necessary steps to ensure that, except with the prior written consent of the CMA:

- (a) the Target business is carried on separately from the Kpler business and the Target business's separate sales or brand identity is maintained;
- (b) the Target business and the Kpler business are each maintained as a going concern and sufficient resources are made available for the development of the Target business and the Kpler business, on the basis of their respective pre-merger business plans;
- except in the ordinary course of business, no significant changes are made to the organisational structure of, or the management responsibilities within, the Target business or the Kpler business;
- (d) the nature, description, range and quality of goods or services (or both) supplied in the UK by each of the Target business and the Kpler business are maintained and preserved;
- Kpler will not take any actions which could impede the Target business from obtaining, sourcing, and using AIS data from its pre-completion suppliers of AIS data;
- (f) except in the ordinary course of business through the separate operation of the two businesses:
 - all of the assets of the Target business and the Kpler business are maintained and preserved, including facilities and goodwill;
 - (ii) none of the assets of the Target business or the Kpler business are disposed of; and
 - (iii) no interest in the assets of the Target business or the Kpler business is created or disposed of;
- (g) there is no integration of the information technology of the Target or Kpler businesses, and the software and hardware platforms of the Target business shall remain essentially unchanged, except for routine changes and maintenance;
- (h) the customer and supplier lists of the two businesses shall be operated and updated separately and any negotiations with any existing or potential customers and suppliers in relation to the Target business will be carried out by the Target business alone and for the avoidance of doubt:
 - (i) the Kpler business will not negotiate on behalf of the Target business (and vice versa) or enter into any joint agreements with the Target business (and vice versa); and

- (ii) Kpler will not attempt to influence the terms the Target business offers to its current or future customers:
- (i) all contracts of the Target business and the Kpler business continue to be serviced by the business to which they were awarded;
- (j) no changes are made to key staff of the Target business or the Kpler business;
- (k) no key staff are transferred between the Target business and the Kpler business:
- (I) all reasonable steps are taken to encourage all key staff to remain with the Target business and the Kpler business; and
- (m) no business secrets, know-how, commercially-sensitive information, intellectual property or any other information of a confidential or proprietary nature relating to either of the two businesses shall pass, directly or indirectly, from the Target business (or any of its employees, directors, agents or affiliates) to the Kpler business (or any of its employees, directors, agents or affiliates), or vice versa, except where strictly necessary in the ordinary course of business (including, for example, where required for compliance with external regulatory or accounting obligations or for due diligence, integration planning or the completion of any merger control proceedings relating to the transaction) and on the basis that, should the transaction be prohibited, any records or copies (electronic or otherwise) of such information that have passed, wherever they may be held, will be returned to the business to which they relate and any copies destroyed.

COMPLIANCE

- 6. The Addressees shall take all necessary steps to ensure that each of their subsidiaries complies with this Initial Order as if the Initial Order had been issued to each of them.
- 7. The Addressees shall provide to the CMA such information or statement of compliance as it may from time to time require for the purposes of monitoring compliance by the Addressees and their subsidiaries with this Initial Order. In particular, two weeks after the date of completion and subsequently every two weeks (or, where this does not fall on a working day, the first working day thereafter) the Chief Executive Officer of Kpler, CanadaCo and UKCo or other persons of Kpler, CanadaCo and UKCo as agreed with the CMA shall, on behalf of

- Kpler, CanadaCo and UKCo provide a statement to the CMA in the form set out in the Annexes to this Initial Order confirming compliance with this Initial Order.
- 8. At all times, the Addressees shall actively keep the CMA informed of any material developments relating to the Target business or the Kpler business, which includes but is not limited to:
 - (a) details of key staff who leave or join the Target business or the Kpler business;
 - (b) any interruption of the Target or Kpler business (including without limitation its procurement, production, logistics, sales and employee relations arrangements) that has prevented it from operating in the ordinary course of business for more than 24 hours:
 - (c) all substantial customer volumes won or lost or material changes to the customer contracts for the Target or Kpler business including any substantial changes in customers' demand; and
 - (d) substantial changes in the Target or Kpler business's contractual arrangements or relationships with key suppliers.
- 9. If the Addressees have any reason to suspect that this Initial Order might have been breached they shall immediately notify the CMA and any monitoring trustee that the Addressees may be directed to appoint under paragraph 10.
- 10. The CMA may give directions to a specified person or to a holder of a specified office in any body of persons (corporate or unincorporated) to take specified steps for the purpose of carrying out, or ensuring compliance with, this Initial Order, or do or refrain from doing any specified action in order to ensure compliance with the Initial Order. The CMA may vary or revoke any directions so given.
- 11. The Addressees shall comply in so far as they are able with such directions as the CMA may from time to time give to take such steps as may be specified or described in the directions for the purpose of carrying out or securing compliance with this Initial Order.

ENFORCEMENT

12. Section 94 of the Act places a duty on any person to whom an initial enforcement order relates to comply with it. Any person who suffers loss or damage due to a breach of this duty may bring an action. Section 94 of the Act also provides that the CMA can seek to enforce the initial enforcement order by civil proceedings for an injunction or for any other appropriate relief or remedy. Under sections 94AA

and 94AB of the Act, the CMA can impose financial penalties in respect of a failure to comply with an initial enforcement order without reasonable excuse as set out in Annex 2 and the <u>Administrative penalties: Statement of Policy on the CMA's approach (CMA4)</u>.

13. It is a criminal offence under section 117 of the Enterprise Act 2002 for a person recklessly or knowingly to supply to the CMA information which is false or misleading in any material respect. Breach of this provision can result in fines, imprisonment for a term not exceeding two years, or both (Section 117 of the Enterprise Act 2002). In addition, the CMA can impose penalties if a person has, without reasonable excuse, supplied to the CMA information which is false or misleading in any material respect (Section 110(1A)) as described in Annex 2 and the Administrative penalties: Statement of Policy on the CMA's approach (CMA4).

INTERPRETATION

- 14. The Interpretation Act 1978 shall apply to this Initial Order as it does to Acts of Parliament.
- 15. For the purposes of this Initial Order:

'the Act' means the Enterprise Act 2002;

'the Addressees' means Kpler, CanadaCo and UKCo;

'an affiliate' of a person is another person who satisfies the following condition, namely that any enterprise (which, in this context, has the meaning given in section 129(1) of the Act) that the first person carries on from time to time and any enterprise that the second person carries on from time to time would be regarded as being under common control for the purposes of section 26 of the Act;

'AIS data' means Automatic Identification System data;

'business' has the meaning given by section 129(1) and (3) of the Act;

'CanadaCo' means exactEarth Ltd., a company registered in 260 Holiday Inn Drive, Unit 30, Building B, Cambridge, Ontario, Canada, N3C 4EB;

'commencement date' means the date of completion of the transaction;

'control' includes the ability directly or indirectly to control or materially to influence the policy of a body corporate or the policy of any person in carrying on an enterprise;

'the decisions' means the decisions of the CMA on the questions which it is required to answer by virtue of section 35 or 36 of the Act;

'Initial Order' means this initial enforcement order made by the CMA on 16 April 2025 and addressed to the Addressees:

'**key staff**' means staff in positions of (i) executive or managerial responsibility or (ii) whose performance affects the viability of the business;

'**Kpler**' means Kpler Holding SA and its subsidiaries. Kpler Holding SA has its registered office at Avenue des Celtes 20/8, 1040 Brussels, Belgium;

'the Kpler business' means the business of Kpler and its subsidiaries but excluding the Target business, carried on as at the commencement date;

'the ordinary course of business' means matters connected to the day-to-day supply of goods or services (or both) by the Target or Kpler and does not include matters involving significant changes to the organisational structure or related to the post-merger integration of the Target and Kpler;

'specified period' means the period beginning on the commencement date and terminating in accordance with section 72(6) of the Act;

'**Spire**' means Spire Global, Inc. and its subsidiaries. Spire Global, Inc, has its registered office at 8000 Towers Crescent Drive Suite 1100, Vienna, Virginia 22182, United States of America;

'**subsidiary**', unless otherwise stated, has the meaning given by section 1159 of the Companies Act 2006;

'the Target business' means the maritime data business and assets of Spire (including, but not only, IP, employees, and customer and supplier contracts) that were subject of the transaction as at the commencement date;

'the transaction' means the transaction by which Kpler and the Target business will cease to be distinct within the meaning of section 23 of the Act;

'the two businesses' means the Kpler business and the Target business;

'UKCo' means exactEarth Europe Limited, a company registered in Sandhills Farm Braintree Road, Wethersfield, Braintree, Essex, CM7 4AG (company number 07267150).

unless the context requires otherwise, the singular shall include the plural and vice versa.

ANNEX 3

PART A - ENFORCEMENT OF AN INITIAL ENFORCEMENT ORDER ISSUED UNDER SECTION 72(2) OF THE ACT – IMPOSITION OF CIVIL PENALTIES

Imposition of civil penalties

- 1. Under section 94AA(1), the CMA may impose a penalty on a person—
 - (a) from whom the CMA has accepted an enforcement undertaking, or
 - (b) to whom an enforcement order is addressed,
 - where the CMA considers that the person has, without reasonable excuse, failed to comply with the undertaking or order.
- 2. In deciding whether and, if so, how to proceed under section 94AA(1) the CMA must have regard to the statement of policy which was most recently published under section 94B at the time of the failure to comply.

Amount of penalty

- 3. A penalty under section 94AA(1) is to be such amount as the CMA considers appropriate.
- 4. The amount must be—
 - (a) a fixed amount,
 - (b) an amount calculated by reference to a daily rate, or
 - (c) a combination of a fixed amount and an amount calculated by reference to a daily rate.
- 5. A penalty imposed under section 94AA(1) on a person who does not own or control an enterprise must not—
 - (a) in the case of a fixed amount, exceed £30,000;
 - (b) in the case of an amount calculated by reference to a daily rate, exceed £15,000 per day;

- (c) in the case of a fixed amount and an amount calculated by reference to a daily rate, exceed such fixed amount and such amount per day.
- 6. A penalty imposed under section 94AA(1) on any other person must not—
 - in the case of a fixed amount, exceed 5% of the total value of the turnover (both in and outside the United Kingdom) of the enterprises owned or controlled by the person on whom it is imposed;
 - (b) in the case of an amount calculated by reference to a daily rate, for each day exceed 5% of the total value of the daily turnover (both in and outside the United Kingdom) of the enterprises owned or controlled by the person on whom it is imposed;
 - (c) in the case of a fixed amount and an amount calculated by reference to a daily rate, exceed such fixed amount and such amount per day.
- 7. In imposing a penalty by reference to a daily rate—
 - (a) no account is to be taken of any days before the service on the person concerned of the provisional penalty notice under section 112(A1), and
 - (b) unless the CMA determines an earlier date (whether before or after the penalty is imposed), the amount payable ceases to accumulate at the beginning of the day on which the person complies with the enforcement undertaking or enforcement order.

PART B - PENALTIES FOR THE PROVISION OF FALSE OR MISLEADING INFORMATION

Imposition of civil penalties

- 8. Under section 110(1A) of the Act, the CMA may impose a penalty on a person in accordance with section 111 of the Act where the CMA considers that:
 - (a) The person has, without reasonable excuse, supplied information that is false or misleading in a material respect to the CMA in connection of any of the CMA's functions under Part 3 of the Act;
 - (b) The person has without reasonable excuse, supplied information that is false or misleading in a material respect to another person knowing that the information was to be used for the purpose of supplying information to the CMA in connection with any function of the CMA under Part 3 of the Act.

9. Under section 110(1C) of the Act, the CMA may not impose such a penalty in relation to an act or omission which constitutes an offence under section 117 of the Act if the person has, by reason of the act or omission, been found guilty of that offence.

Amount of penalty

- 10. Under section 111(1) of the Act, a penalty imposed under section 110(1A) of the Act shall be of such amount as the CMA considers appropriate.
- 11. A penalty imposed under section 110(1A) of the Act on a person who does not own or control an enterprise shall be a fixed amount that must not exceed £30,000.
- 12. Under section 111(4A) of the Act a penalty imposed under section 110(1A) of the Act on any other person shall be a fixed amount that must not exceed 1% of the total value of the turnover (both in and outside the United Kingdom) of the enterprises owned or controlled by the person.
- 13. In deciding whether and, if so, how to proceed under section 110(1A) of the Act, the CMA must have regard to the statement of policy which was most recently published under section 116 of the Act at the time when the act or omission occurred.
