Creation date	The charge creation date of some charges were found to be inconsistent with the registration date. A decision has been taken to remove the charge creation date	<p>Before: Creation date population</p> <p>After: Creation will not be revealed</p>
Further information location	Field updated to direct users to most appropriate place for further information on a charge.	<p>Before: English Nature, The Maltings, Wharf Road, Grantham, NG31 6BH &, South Kesteven</p> <p>After: https://designatedsites.naturalengland.org.uk/SiteSearch.aspx</p>
Listed Buildings	A change in the way that curtilage is captured for Listed Buildings.	<p>Before: Only the extent for the primary building was captured and manually referred at time of search request to see if curtilage applies</p> <p>After: Listed Buildings have been considered, and the extent now includes the curtilage where applicable</p>
Statutory Provisions	Statutory Provisions were updated to match the HMLR approved statutory provision format.	<p>Before: Approval of Reserved Matters - Town and Country Planning Act 1990</p> <p>After: Town and Country Planning Act 1990</p>
Textual data – Personally Identifiable Data	Where personally identifiable data was found in the supplementary information, this has now been removed.	<p>Before: Some charges would have a persons name, telephone number or email address for a customer.</p> <p>After: This data has been removed to adhere to General Data Protection Regulation (GDPR) protocols</p>



Spatial Data	All charges contain an appropriate geometry.	<p>Before: Not all charges had a geometry or had invalid geometry.</p> <p>After: All charges have an appropriate representation of the charge extent.</p>
Textual data - Charge types and sub-categories	All charges in the Register now contain a charge type and a sub-category in accordance with the HMLR schema.	<p>Before: Inconsistencies in charge-types, sub-categories, instruments, and statutory provisions found.</p> <p>After: Charge type mapping successfully applied to all charges where applicable in accordance with the HMLR schema to show relevant charge-types, sub-categories etc</p>
Textual data - Addresses	Addresses have been populated for all charges.	<p>Before: Some charges would only have an address referenced in the description of the charge.</p> <p>After: All charges have addresses or a geographic description of the affected land.</p>
Financial Charges	Rate of interest has been populated with a numerical value for all part 2 charges.	<p>Before: Some charges did not have a populated rate of interest field.</p> <p>After: Rate of interest has been populated with a numerical values for all part 2 charges</p>
Textual data-supplementary information	Where invalid descriptions of charges were found in supplementary information, this has now been removed.	<p>Before: Idox.TlcHmlr.Shared.Impl.TlcApi.Dto.ApiObjects.GetRecords.ApildoxTlcDataRecordField</p> <p>After: Full description of charge, text refined to provide full charge description within field character limit</p>
