DECISION

The sum of £709.50 per month will be registered as the fair rent with effect from 13th February 2025 being the date the Tribunal made the Decision.

REASONS FOR THE DECISION

Background

1. On 31st October 2024, the Rent Officer registered a rent of £700.00 per calendar month, effective from 6th December 2024. Following an objection from the Landlord to the determination of a fair rent by the Rent Officer, the Tribunal has made a determination under the provisions of the Rent Act 1977.

Inspection

2. The Tribunal did not inspect the property but considered this case on the basis of the papers provided by the parties and having regard to its own knowledge, expertise and online research.

Evidence

- 3. The Tribunal has considered the written submissions provided by the Tenant and the Landlord. From the information provided it appears that the subject property comprises a semi-detached, 3-bedroom, double-glazed and centrally heated dwelling with gardens to front and rear together with off-road parking.
- 4. The Tribunal notes that the central heating, white goods and carpets & curtains have been provided by the Tenant.
- 5. The Tribunal further notes from the Tenant's submissions that they have carried out extensive improvements including:-
 - Gas fire central heating plus fitted gas fire to the living room
 - Plastered and skimmed walls to the kitchen and installation of kitchen cupboards and worktops
 - Replaced internal doors, light switches and sockets
 - Installation of laminate flooring to the living room and bedroom 2
 - Replacment bathroom suite
 - Fitted mirrored wardrobes in Bedroom 2
 - Blocked paved driveway and parking for 2 vehicles
 - Installation of uPVC clad lean-to, and
 - Erection of 2 garden sheds, decking and patio.
- 6. The Tenant has not submitted any comparable evidence. The Landlord has provided extracts of comparable open market lettings ranging from £1,250 to £1,450 per calendar month including a confirmation email from Dixons Countrywide of the letting of 207 Castle Street on 25th November 2024 at £1,450 per calendar month.

Determination and Valuation

- 7. On consideration of the comparable evidence provided by the Landlords, that forwarded by the Rent Officer and the Tribunal's own expert knowledge of rental values in the area, the Tribunal considers that the open market rent for the property in a satisfactory condition would be in the region of £1,450 per month. From this level of rent, the Tribunal has made adjustments in relation to the following:
 - a) The condition of the property
 - b) Improvements made by the Tenant as outlined in Para.5. above
 - c) Curtains, carpets and white goods fitted by the Tenant.
 - d) The Tenant's liability to redecorate.
- 8. The Tribunal has also made an adjustment for scarcity using their own general knowledge and experience. The Tribunal considers that in the wider geographical area there is an imbalance of supply and demand impacting on rental values and has, therefore, made a reduction of 15% for scarcity.
- 9. The full valuation is shown below:

10. The Tribunal determines an uncapped fair rent of £769 per month on adopting scarcity at 15% of the amended rent following consideration of \$70 (3) Rent Act 1977.

Decision

- 11. The uncapped fair rent determined by the Tribunal, for the purposes of section 70, is therefore £769 per month however the maximum fair rent permitted by the Rent Acts (Maximum Fair Rent) Order 1999 is £709.50 per month, this therefore limits the fair rent to be registered. The calculation of the capped rent is shown on the decision form.
- 12. The rent to be registered is therefore £709.50 per calendar month with effect from 13^{th} February 2025.

Explanatory Note

- 1. The calculation of the maximum fair rent, in accordance with the formula contained in the Order, is set out above.
- 2. In summary, the formula provides for the maximum fair rent to be calculated by:
 - (a) increasing the previous registered rent by the percentage change in the retail price index (the RPI) since the date of that earlier registration and
 - (b) adding a further 7.5% (if the present application was the first since 1 February 1999) or 5% (if it is a second or subsequent application since that date).
 - A 7.5% increase is represented, in the calculation set out above, by the addition of 1.075 to (B) and an increase of 5% is represented by the addition of 1.05 to (B).

The result is rounded up to the nearest 50 pence.

- 3. For the purposes of the calculation the latest RPI figure (x) is that published in the calendar month immediately before the month in which the Tribunal's fair rent determination was made.
- 4. The process differs where the tenancy agreement contains a variable service charge and the rent is to be registered as variable under section 71(4) of the Rent Act 1977. In such a case the variable service charge is removed before applying the formula. When the amount determined by the application of the formula is ascertained the service charge is then added to that sum in order to produce the maximum fair rent.
