**SUMMARY REASONS**

**Background**

1. Following an objection from the Tenant to the determination of a fair rent by the Rent Officer, the Tribunal has made a determination under the provisions of the Rent Act 1977.

### **Inspection**

2. The Tribunal did not inspect the property but considered this case on the basis of the papers provided by the parties. The property comprises a terraced house centrally heated, with 2 rooms a kitchen and a WC on the ground floor. On the first floor 3 rooms a bath and WC. Outside there is a garden.

### **Evidence**

3. The Tribunal has had consideration of the written submissions provided by the Tenant and the Landlord.

### **Determination and Valuation**

4. Having consideration of any comparable evidence proved by the parties and our own expert, general knowledge of rental values in the area, we consider that the open market rent for the property in good tenable condition would be in the region of £2600.00 per calendar month. From this level of rent we have made adjustments in relation to:

Tenants' responsibility for internal decoration 10%

5. The Tribunal has also made an adjustment for scarcity of 20%.

6. The full valuation is shown below:

7. The Tribunal determines a rent of £1872.00 per calendar month inclusive of £1.67 service charge per month.

### **Decision**

8. The uncapped fair rent initially determined by the Tribunal, for the purposes of section 70, was £1872.00 per month. The capped rent for the property according to the provisions of the Rent Acts (Maximum Fair Rent) Order 1999 is calculated at £1051.00 per month inclusive of service charge of

£1.67 per month. The calculation of the capped rent is shown on the decision form. In this case the lower rent of £1051.00 per month inclusive of £1.67 per month service charge is registered as the fair rent of this property.
