**A Response to the HMI Probation Inspection:** A thematic inspection on the use of electronic monitoring as a tool for the Probation Service in reducing reoffending and managing risk.

**Report Published:** 18<sup>th</sup> January 2022.

## INTRODUCTION

HM Inspectorate of Prisons (HMIP) and HM Inspectorate of Probation for England and Wales are independent inspectorates which provide scrutiny of the conditions for, and treatment of prisoners and offenders. They report their findings for prisons, Young Offender Institutions, and effectiveness of the work of probation, and youth offending services across England and Wales to Ministry of Justice (MoJ) and His Majesty's Prison and Probation Service (HMPPS). In response to the report HMPPS / MoJ are required to draft a robust and timely action plan to address the recommendations. The action plan confirms whether recommendations are agreed, partly agreed, or not agreed (see categorisations below). Where a recommendation is agreed or partly agreed, the action plans provide specific steps and actions to address these. Actions are clear, measurable, achievable, and relevant with the owner and timescale of each step clearly identified. Action plans are sent to HMIP and published on the GOV.UK website. Progress against the implementation and delivery of the action plans will also be monitored and reported on.

Data requirements for the new future service have been documented and shared with potential suppliers which allow for improved access and accuracy of EM data. The first iteration of the EM Future Service Data Dictionary has been drafted to enable more comprehensive data coverage, collection and flexibility to change data items. 			<p><b>Action 4:</b> A regular quarterly publication of EM data has been established, with the last report published October 2022 and the next one due in January 2023. Age and gender breakdowns are included in the annual version of this report.</p> <p>Due to the scale of challenges uncovered regarding the data required to produce more detailed reports on protected characteristics, the specific objective to ‘Develop regular management information tools... to be produced at a minimum quarterly’ was not achieved by December 2022. These challenges include significant gaps in data capture, technical constraints in accessing and linking various datasets, and the poor quality of data. This is further hampered by a lack of documentation to support our understanding of the EM data.</p> <p>Work to address this is ongoing and Data Scientists – working from a historical curfew dataset – have developed a model to focus existing EM data on the person as opposed to the order. This will make it easier to match person to person data in other datasets. A model for matching has been built and the linking of EM data to Probation data held in nDelius was completed in October 2022. This provides a baseline dataset and will be made available to analysts for interrogation. To generate regular reporting updates, the work done to link the datasets would need to be adapted to establish a data pipeline using the EM extracts that are received on a regular basis.</p> <ul style="list-style-type: none"> <li>• Some tag-wearers, who will be included in the EM dataset, will not have a corresponding record in the nDelius dataset due to not yet being sentenced.</li> <li>• The nDelius dataset includes ethnicity and disability, however the ethnicity data field is only approximately 80% populated and the disability field less so.</li> </ul> <p>The linked dataset is currently subject to a Data Privacy Impact Assessment (DPIA) – see update under Recommendation 1, Action 5. Once approval is obtained, analysts will need time to interrogate the linked datasets, after which we will have a better understanding of what insight can be derived from them, within the limitations described above. Further time will be needed to develop and test the tools required to provide regular management information at a suitable frequency of refresh. Due to these uncertainties, an approximate timescale for completion is June 2023.</p> <p>Given that protected characteristics (in the main) remain static, it was agreed that reporting should be annual, in line with other offender equalities reporting, rather than “at least quarterly”. 			<p><b>Action 5:</b></p> <p>The MoJ Data Strategy was published in September 2022. An EM Data Improvement Plan, which sets out how we will commence delivery against the strategy, has been developed. 			<p><b>Update Jan 2024:</b></p> <p><b>Action 4:</b> The December 2022 target was not met due to the scale of challenges identified, including significant gaps in data capture, technical constraints in accessing and linking various datasets, the poor quality of data and a lack of supporting documentation. It was determined that reporting should be annual, in line with other offender equalities reporting, rather than “at least quarterly” as stated in the Action.</p> <p>There has been some progress made despite the challenges with the data. 


			<p><b>Update January 2023:</b></p> <p><b>Action 1, 2 and 3:</b> EM commissioned an external Digital Discovery project through OpenCast in Spring 2022 and the final report, 'Electronic Monitoring Data Discovery', was completed in June 2022.
